

## TERMS AND CONDITIONS

1. The offset price of the vehicle No.OR-02-F-7709( Mahindra & Mahindra Diesel Jeep) is Rs. 25,000.00(Rupees twenty five thousand) only.
2. If the last date for the submission of the bid turns out to be a holiday it will automatically be extended to next working day.
3. A bid cannot be withdrawn in any circumstances.
4. The participants should submit the copy of proof of residential address and proof of identity with the bid.
5. The participant/bidder should deposit an earnest money (EMD) amounting to Rs.1000.00 (Rupees one thousand) only for the vehicle in shape of demand draft from any Nationalized Bank / Scheduled Bank drawn in favour of the District Panchayat Officer, Jharsuguda to be payable at Jharsuguda and the same in original be submitted with the offer/bid at the time of submission.
6. The EMD shall be refunded to the unsuccessful participant / bidder after completion of the auction sale.
7. The undersigned shall not be, in any case, responsible for late submission / receipt of the offer/bid in any matter.
8. The participant/bidder quoted highest offered shall deposit 25% of the offer amount then and there as the initial deposit and he/she shall deposit the rest of the offered amount within seven days of the deposit of the initial amount. In case he/she fails to deposit the total offer amount within the stipulated time, the deposit, including the earnest money (EMD) shall be forfeited. The EMD of the successful bidder will be adjusted at the time of final payment of the offer amount in time. GST as per rule shall be levied on the offered price payable by the participant/bidder.

In case of failure to deposit the full amount within the stipulated time by the successful participant/bidder, negotiation among the other unsuccessful participant/bidder will be made, if so requires, to take the vehicle on deposit of the highest auction price offered by the first participant/bidder.
