**ADVERTISEMENT FOR ENGAGEMENT OF CRCCs ON DEPLOYMENT BASIS 2018**

Applications are invited from the Level-IV/V teachers of elementary cadre for engagement of CRCCs on deployment basis in different Clusters of Jharsuguda District. The details of eligibility criteria and mode of applications are given below.

**Eligibility Criteria for engagement of CRCCs.**

1. For the post of CRCC, the applicants must be Level-IV/V teacher of elementary cadre except Ex Cadre as per vide Letter No.6446/TT/18, dtd.05.07.18 of OPEPA, Bhubaneswar. In case of non-availability of candidate of Level-IV/V teacher, the teacher engaged under Zilla Parishad may also be considered for the post of CRCC, 2. Proficiency in subject based competencies. 3. Capability for resolving different pedagogical issues/practices 4. The applicant should have at least 10 years of teaching experience and five years of service before retirement. Application may be considered, in case of non-availability of candidates under these criteria by the selection committee 5. The teachers who have completed more than 5 years of service as CRCCs are not eligible for the said post.

**Mode of Application:** The application is to be submitted the office of the District Project Coordinator, RTE-SSA, Jharsuguda by Speed Post/ Regd. Post/ by hand on or before dtd.31.08.18. Application received after due date will not be taken into consideration.


