

Quotation Call Notice No. **308** /Elec. Dated. **28-08-2018**

Sealed quotations in plain paper are invited from intending Register Firms/ Agencies for following purposes in connection with Simultaneous General Election, 2019.

- 1) For installation of CCTVs for EVM Strong room/ FLC Hall.
- 2) Webcasting of the critical and Vulnerable Polling Stations
- 3) Videography.

The quotationers are informed to quote their **rate per day** as well as **one hour** for separately on above item of works. They are also required to mention availability of number of CCTV and Video Camera at their firm separately with handing of the same by one person for one item.

The Quotation should reach in the District Election Office, Jharsuguda on or before **1.30 PM on dated 10.09.2018** and it will be opened on the same day at **4.00 PM** in the presence of the District Election Officer, Jharsuguda or by a committee duly authorized by him. The quotationers or his authorized agent should be present at the time of opening of the quotation on the date and time fixed. Negotiation may be made for finalization of rate with the quotation.

The quotationers should have valid GST No. (Self attested copy of the GST Registration Certificate is to be submitted), must submit copy showing up to date deposit of GST and valid PAN (copy to be submitted).

Each quotationer shall have to deposit non-interest EMD of **Rs.10,000/-** (Rupees Ten thousand) only in shape of account payee/ Bank Draft payable to the District Election Officer, Jharsuguda which will be refunded to the unsuccessful quotationers or whose quotation are not accepted. The EMD of the successful quotationer will be refunded after completion of the validity period. The total offer price per unit shall be inclusive of GST, transportation and installation charges.

The successful firm/ bidder must sign an agreement for a period of one year from the date of signing of agreement / finalization of tender and will complete the delivery of items 5 days unflinching after issue of work order, failing which the order will stand automatically cancelled. The rate of unit-wise item should be quoted distinctively. Failure to supply the order in full within the stipulated period may lead to forfeiture of EMD and action as deemed proper shall be initiated against the quotationer.


