

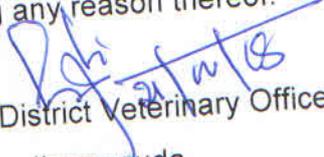

SHORT TENDER CALL NOTICE

Sealed tenders in the prescribed proforma are invited from the reputed manufacturers or their authorized distributors / dealers for supply of refrigerators and stabilizers /Computer with Printer / Inverter for use in different blocks of the district. The tender documents with detail informations on the items and their specifications, terms and conditions can be obtained from the Office of the Chief District Veterinary Officer, Jharsuguda on payment of Rs. 200/- from **Dt.22.12.2018 to Dt. 31.12.18** during office hours or can be downloaded from the website of district portal <https://Jharsuguda.nic.in> from **Dt.22.12.2018 to Dt. 31.12.18**. In case the application form is downloaded from the website, the applicant shall furnish a Demand Draft for an amount Rs.200/-(Rupees One Hundred) only towards the cost of application along with the application. When the application form is purchased from the office of the CDVO, Jharsuguda the copy of the money receipt towards deposit of Rs.200/- for application form to be furnished while submitting the filled in application form.

The bidders should submit their offers in the prescribed format along with the self attested photocopies of the requisite documents addressing to the "Chief district Veterinary Officer, Jharsuguda " in sealed covers super-scribing "Tender for supply of Refrigerators/Stabilizers/Computer with Printers/ Inverter ". The sealed tenders completed in all respect should reach the undersigned on or before **31.12.18 by 12.30 p.m.** The tenders received after due date and time will not be entertained. The undersigned reserves the right to cancel/reject the quotation without assigning any reason thereof.

General Terms & conditions:

1. The items should be of brands of National / International repute. The authorized dealer/distributor has to provide supportive documents.
2. The firms / tenderer should have valid TIN, PAN/ TAN, VAT (self attested photocopy to be submitted along with application)
3. The prices quoted are to be in Indian rupees and should be inclusive of all taxes as per the prescribed format.
4. The tenderer can submit the quotation for any one of the item or all the items together in one quotation form.
5. The tenderer should deposit earnest money of Rs 6000/- (Rupees six thousands only) in shape of account payee bank draft drawn in favour of Chief District Veterinary Officer, Jharsuguda payable at SBI Main Branch Jharsuguda along with the tender which will be refundable to the tenderers whose quotations are not accepted. The security deposit of the successful tenderer shall be released without any interest after receiving satisfactory performance report on expiry of rate contract.
6. The quotation should reach the Office of the CDVO, Jharsuguda by 12.30 pm of 31st December ,2018 & the same shall be opened in the office of the purchaser same day at 2.30 p.m. by a committee constituted for the purpose in presence of tenderers or their authorized representatives if they so desire.
7. The quotation received in incomplete form or after the schedule date & time shall be summarily rejected. The authority reserves the right to reject all or any quotation without assigning any reason thereof.
8. The items are to be provided by the successful tenderer as per the standard specified in the document within a period of 7days from the receipt of purchase order.
9. Successful tenderer shall not be entitled to any hike in prices for any reason other than statutory levies during the period of supply of item.
10. The payment will be made after delivery of the goods in proper condition at the office of the Chief Dist. Vety. Officer, Jharsuguda through RTGS after submission of the bills and the bidder or the quotationer shall be responsible for any type of loss, theft, breakage of goods during transportation. All the aspects of safe delivery shall be the exclusive responsibility of the supplier.
11. The Validity of rates quoted and terms & conditions will be for a period of one year from the date of award of contract.
12. Any legal dispute arising out of this is subject to the concerned district jurisdiction only.
13. The items should be backed by at least one year warranty support during which service/maintenance and other related service should be provided at no extra cost.
