


1. The firm should have adequate no. of qualified engineers under its to take up such work.

Terms and conditions :-

1. The cost of bid documents (non-refundable) mentioned in column No. 5 should be deposited in shape of cash/demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Brajrajnagar Municipality payable at Brajrajnagar.
2. The cost of security deposit mentioned in column No. 3 should be deposited in shape of demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Brajrajnagar Municipality payable at Brajrajnagar.
3. The intending firms/ organizations/ experts should submit individual covers super scribing the title of the project against each of above projects. Quotation for more than one project in one envelop would result in rejection of both the quotations in respect of superscription on the envelope.
4. Quoted rates should be quoted clearly in both figures & words with corrections duly attested by the quotationers.
5. Intending quotationers should possess prior experience in execution of identical nature of work in govt. organizations/ ULBs/ PSUs etc.
6. The quotationers should submit detailed & satisfactory establishment information capable for preparation & supervision of such project.
7. The firm/ institution should have GST Registration certificate, PAN as well as I.T.C.C upto date. No undertaking would be allowed against non-submission of any required document.
8. It would be the responsibility of the quotationer to get the DPR duly technically sanctioned by competent authority. The structural design should be prepared and certified by qualified structural Engineer as per I.R.C codal procedure.
9. D.P.R. should be submitted in both hard as well as soft copy for power point presentation.
10. **Mode of payment:**
 - (i) At the period of submission of DPR-@20%
 - (ii) After technical sanction from competent authority-@30%
 - (iii) After floating of e-procurement-@30%
 - (iv) During the period of supervision/completion-@20%
