Sealed quotation/ tender are invited from interested reputed Travel Agencies/ Tour operators or private individuals for providing 1 (One) no. of Non AC/ AC Diesel driven vehicle (Marshal/ Mahindra Max/ Bolero/ Tata Sumo) having sitting capacity more than ten including driver, which shall conform to the terms and Conditions mentioned in **Annexure-II** of Letter No. 34085/Dt. 29.09.2012 & Letter No. 27037/Dt. 08.10.2015 of Finance Deptt., Govt. of Odisha, for office use in **Tahasil Office, Laikera** on monthly rent basis for a Period of One year.

1. The vehicle must be in good condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up-to-date tax payment etc. which are mandatory for playing of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of **TAHASILDAR, LAIKERA** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge is quoted separately in the general bid information (excluding fuel and lubricants).
6. The vehicle must achieve a fuel efficiency of 12 to 15 Kms per liter.
7. The details of the make and year of manufacture of the vehicle, registration number, mileage (KMs per liter) and name of the Driver with Driving License Number and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender (Annexure-III).
8. The Quotation completed in all respect should reach the undersigned on or before dt. 09.03.2019 by 5.00 PM and shall be opened on 11.03.2019 at 10.00 AM in presence of the bidders or their authorized representatives.
