

2. Tender for the vehicle indicating offer price and bearing the inscription "**Tender for sale of Vehicle No. OR-15A-7422**" may be addressed to Sub-Collector, Jharsuguda and shall be submitted in person on or before **15.07.2019 at 3 PM.**
3. Tender must be accompanied with an EMD (refundable) in shape of Demand draft of Rs. 5000/- (five thousand only) from any nationalized bank drawn in favour of "**Sub-Collector, Jharsuguda**" payable at **Jharsuguda.**
4. Tender should contain a self attested copy of ID proof of the bidder.
5. Tenders will be opened by a committee constituted for this purpose at 4 PM on **15.07.2019** in the Office chamber of Sub-Collector, Jharsuguda in presence of bidders or their authorized representatives.
6. Highest bidder has to deposit 50% of bid amount immediately and rest amount within 24 hours.
7. If the highest bidder fails to deposit full amount within stipulated period then his EMD along with 50% of bid value so deposited shall be forfeited and his claim on the auction sale also stands forfeited.
8. It is the responsibility of the final bidder to get the relevant papers of the vehicle transferred in his own name and pay tax, fee etc. as relevant in Odisha.
9. The final bidder shall transfer the vehicle to his name within 72 hours from deposit of full bid value and the vehicle shall be delivered to him only after transfer of ownership in his name.
10. In case the bidder fails to apply for transfer the ownership to his name within stipulated period or if he do not remove the vehicle within 24 hours of transfer of ownership in his name then ground rent @1% of bid value may be imposed upon him.

12. The undersigned also reserve right to negotiate with all or highest bidder.


