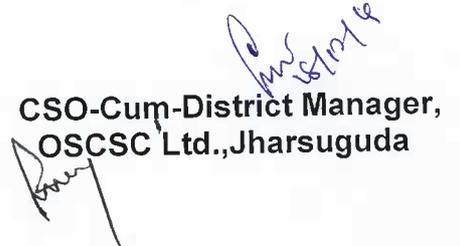

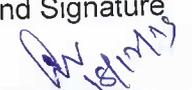

Sealed quotation are invited from interested reputed Travel Agencies/Tour operators or private individuals for providing one no of Non AC Bolero driven vehicle having sitting capacity not more than five including driver, which shall confirm to the Terms and conditions for official use in the office of the CSO-Cum-District Manager, OSCSC Ltd., Jharsuguda on monthly rent basis.

- 1) The vehicle must be in Road worthy Condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance certificate, Fitness Certificate, pollution certificate, Valid Contract Carriage permit, proof of upto date tax payment etc. Which are mandatory for plying of vehicle.
- 2) The driver of the vehicle must have a valid Driving License for Driving light transport passenger vehicle and should be sufficiently experienced in Driving transport vehicle.
