Sealed tenders are invited from intending Reputed Firms having valid TIN, PAN, GST Registration and Income Tax Return certificates for printing of multi coloured LOGO on tile of 2 feet x 2 feet size under " Ama Gaon Ama Bikash" Yojana for supply to all 5 Blocks of Jharsuguda District. The approximate number of logos to be printed is 560. The tenderers are to quote the rate per piece including the cost of tile since the selected tenderer will have to arrange the tiles as per the specified size. For finalization of the tender, the quality of tiles will also be considered. Hence, a sample of tile of 2 feet x 2 feet size printed with logo should be placed before the committee by the tenderer to ascertain the quality at the time of opening of the tender. TERMS AND CONDITIONS FOR SUBMISSION OF TENDER

The following terms and conditions must be adhered to by the successful bidder for supplying the required tiles printed with logo:-

1. The tender papers completed in all respect should reach the office of the Project Director, DRDA, Jharsuguda, At- DRDA Building (Near Collectorate), Post- OMP Line, Jharsuguda, PIN- 768204 on or before dt:- 11.03.2020 by 3:00 PM through Registered / Speed Post only and shall be opened on the same day at 4:00 PM in presence of the bidders or their authorized representatives.
2. The bidders or their authorized representatives should bring a sample of the tile of 2 feet x 2 feet size printed with multi coloured logo which shall be placed before the tender committee for quality checking on the date of the opening of tender. Non production of the same will lead to rejection of the tender.
3. The tenderer should quote the rate per piece inclusive of tile, all rates and taxes.
4. The tender paper should accompany with Rs. 2,000 (Rupees two thousand only) towards EMD (refundable) and Rs.100/- (Rupees One hundred only) towards cost of tender paper in shape of BC/BD drawn on any Nationalized Bank at Jharsuguda in favour of "Project Director, DRDA, Jharsuguda" payable at Jharsuguda.
