
SEALED QUOTATION CALL NOTICE

Sealed quotation are invited from interested reputed Travel Agencies/Tour Operators of private individuals for providing 1(one) number of Non AC/AC Deisel driven vehicle having sitting capacity not more than ten including driver, which shall confirm to the Terms and conditions (Annexure-II) vide office memorandum No-30464/FDt.06.09.2019 of finance Deptt.Govt of Odisha for official use in Tahasil office,Kirmira on monthly hiring charges basis.

Condition:-


- 1) The vehicle must be in Road worthy condition, shall not be more then 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance certificate, Fitness Certificate, valid carriage permit, proof of up to date tax payment etc which are mandatory for playing of vehicle.
- 2) The Driver of the vehicle must have a valid Driving Licence for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature
- 4) A sum of Rs.5,000/- shall be deposited by the intending bidders in shape of deposit receipt from Nationalized Bank/NSC/KVP duly pledge in favour of the Tahasildar, Kirmira and submitted along with the quotations as security deposit. After competition of the quotations process the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charges be quoted separately in the general bid information (excluding fule and lubricants).
- 6) The vehicle must achieve a fuel efficiency of not less then 10 KMs per litter
- 7) The detail of the make and year manufacture of the vehicle, registration no. mileage (KMs covered per litter) and name of the Driver with driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation or quotations (Annexure-III).
- 8) The Quotation completed in all respect reaches the undersigned on before **20/03/2020 by 2.00PM** and shall be open on the same day at 4.00 P.M in presence of the bidders or their authorized representatives.

- 9) The application form of tender containing General Bid Information & Terms and Conditions for Hiring of vehicles etc will be available in the office of the Tahasildar, Kirmira on payment of Rs.100/-(Rupees One hundred) only during Office hour or can be downloaded from the Odisha Govt. website www.jharsuguda.nic.in . In case the application form is downloaded from Govt.Website, the applicant shall furnish a Demand draft for an amount Rs.100/-(Rupees one hundred)only towards the cost of application along with the application.




