
Order No. 3189 /Emg/ Dated, 25.03.2020//

WHEREAS Government of Odisha in Revenue & Disaster Management Department vide Notification No. 1706/R&DM (DM), dated, 13.03.2020 has declared **COVID-19 as a "Disaster"** for the state of Odisha under section 2(d) of the Disaster Management Act, 2005 and authorized the Disaster Management Authorities in the State to take such action under the Act as may be required for management of the said disaster.

AND WHEREAS the Government of Odisha in Health & Family Welfare Department have framed "**The Odisha COVID-19 Regulation 2020**" for prevention and containment of **CORONA Virus Disease-2019 (COVID-19)** and in the said Notification **Collector, Jharsuguda** has been declared as the "**Empowered Officer**" to take such measures as necessary to prevent the outbreak of COVID-19 or the spread thereof within the district of Jharsuguda.


AND WHEREAS the undersigned is empowered under section 2(1) of the Epidemic Disease Act, 1897 vide Notification No. 7445 Dt. 11.03.2020 of Health and Family Welfare Department, Govt. of Odisha as Empowered Officer.

Therefore, I **Sri Saroj Kumar Samal, OAS(SAG), Collector & District Magistrate, Jharsuguda** being the "**Empowered Officer**" under section 2(1) of the Epidemic Diseases Act, 1897 do hereby direct to seal all the interstate connecting road points such as Kanaktora on NH-49, Lara Chowk near Kandheikela, Ektal Chowk etc. connecting the State of Chhatisgarh in order to prevent Traffic movement and the movement of any vehicle other than that of goods which are specifically exempted by the Government of Odisha vide its notification No 8980/H&FW Dt. 24.03.2020 with effect from Dt. 25.03.2020 till 14.04.2020 to prevent the outbreak of COVID-19 or spread thereof, in the larger interest of general public.






