OFFICE ORDER

Whereas it is observed that the bikers are rendering the lockdown ineffective in different parts of the district despite repeated appeals and restriction by police check posts


Whereas it is necessary to take some strict measures towards ensuring social distance and de-crowding of the streets, roads and public places, more importantly the market places

Whereas the grocery shops and vegetable markets are having dispersed locations across the areas

Whereas, the undersigned is empowered under the COVID-19 Regulation dated 3.4.2020 of Govt. of Odisha in Health & Family Welfare Department and the Epidemic Disease Act 1987 to take enabling measures and COVID-19 having been declared Pandemic and a disaster, the Collector & District Magistrate as the district authority is competent under section 34(b) of the Disaster Management Act-2005 to issue necessary direction for controlling vehicular traffic,

the following order is passed to take effect from 7th April 2020 in the period of lockdown.

- a) The period of permission for purchase of articles like grocery, vegetables and non-veg items will be between 6.00 AM and 10.00 AM in modification of the earlier order for five hours i.e. up to 11.00 AM.
- b) No two wheeler will be used for purchase of commodities except medicines of emergency. People have to walk down to buy all these things.
- c) There will be no vehicle on the road either four wheeler or two wheelers except bicycles and the ones used by the employees of the establishments (public & pvt) allowed to function. However people seeking health services for travel to hospital and medicine shops can use motorized vehicles. They need to satisfy the police and magistrates on duty with updated documents and vouchers that they are health service seekers.
