OFFICE ORDER

No. 4737/Emg

In partial modification of this office order No.4724/Emg, Dt. 25.04.2020 this is to say that market complex in urban areas and urban like areas will mean market complex of Urban Local Bodies, Development Authority and that of private ownership. Further, more than 5 nos of individual shops having contiguity in a linear way irrespective of their ownership will also mean a market complex for the purpose of lockdown.

The shops allowed to remain open in the order said above will have stand-alone locations and in case shops of contiguity upto 5 separate units, no two adjacent shops despite being in the allowed category can remain open and operate simultaneously. They will be opening on alternative days to be decided by the Visiting Squards comprising of Executive Magistrate & Police Officers. Further for the convenience of enforcement and keeping in view the conditions of heat-wave the shops allowed to remain open vide the order dt.25.4.2020 will transact business from 7.00 AM to 12.00 Noon instead of the earlier notified timing of 9.00 AM to 6.00 PM. The timing decided for vegetables, fruits, non-veg items i.e. from 6.00 AM to 11.00 AM and shops of agricultural input, building materials and book stores i.e. from 10.00 AM to 5.00 PM will continue as such. Medicine stores will remain open as usual.

Except the change as mentioned above, this office order no. 4727/Emg, dt.25.4.2020 will hold good. This order of revision and the order no.4724/Emg, dt.25.4.2020 will be read together.




