ORDER

No. 5554/Emg.

Dated: 11th May 2020

In the aftermath of rescinding many of the regulatory stipulations of lockdown it is necessary to have effective adequate enforcement with a view to ensure social distancing and conformity to the residual stipulations in force. This order is being issued in consultation with the Superintendent of Police, Jharsuguda. There will be squad arrangement comprising of the following in different ULBs and Block areas. Accordingly the number of central squads in Jharsuguda Municipality will be two and one each in other Municipalities and Blocks. The squads besides looking after enforcement in regard to the restrictions in force in the phase-3 of lockdown in respective area will also supervise the work of special mobile teams constituted to fine the people deviating from social distancing, wearing of masks and "no spitting" outside. The squad of Blocks may constitute sub-squads looking at the expanse of their area and requirement. The Block level squad comprising of BDO, Tahasildar and IIC of the P.S. will also constitute teams in parlance with Urban teams for fining the people deviating from the following :

- a) Social distancing, b) Mandatory wearing of Masks, c) Not spitting outside.

The Sub-Collector, Jharsuguda will have overall supervision of the enforcement across the district.




