ORDER

Whereas the undersigned deriving power U/s. 8 of COVID Regulations, 2020 framed by Govt. of Odisha and Sec.30 & 34 of Odisha Disaster Management Act, 2005 vide this office Order No.4939/Emg. Dt.29.04.2020 had declared area in a particular circumference around the household of a case detected positive at Budhijam in the Municipality of Brajrajnagar with the following boundary descriptions at "A" as a segment of Containment and the area between the boundary of Containment and an outer line delineated at "B" as Buffer Zone.

Whereas active surveillance in the containment area in the meanwhile has been saturated and the activity of intervention on our part in the Buffer Zone has reached finality.

Now for the sake of restoration of normal life in both the areas, I, Sri Saroj Kumar Samal, OAS, District Magistrate & Collector, Jharsuguda order annulment of the impugned order which gave effect to restriction and regulation with regard to Containment and the activities in Buffer Zone. **This order of rescission will take effect from 12.00 mid-night of 13.05.2020. All the arrangements made by the administration with regard to supply of essential commodities stand withdrawn from 14.05.2020 morning. However the measures of prohibition and restriction for lockdown as pronounced in Order No.5546/Emg. Dt.10.5.2020 will continue to be in force.**

Patajoshi Chowk → Ambedkar Chowk → Gudhababa Temple → Gualapara Durga Temple → Shiv Temple (SubashChowk) → Tunnels Road → Railway Fatak → Lajkura Road → Sittara Chowk → San-Job Primary School → Ramgarh Pond → Mines No.03 Road Chowk → PatajoshiChowk.


Boundary point of Buffer Zone ("B")






