



**REVISED ADVERTISEMENT FOR HIRING OF VEHICLES TO BE ENGAGED

Sealed quotations are invited from interested private vehicle owners/ Service Providers for providing preferably petrol driven vehicle having following terms & conditions for official use in 5 Block Mobile Veterinary Units of Jharsuguda District on monthly rent basis:-


- The Vehicle must be in good condition, shall not be more than 3 years old from the date of initial registration.
- Model of the vehicle (TUV 300/ Bolero/ Sumo Gold/ Ertiga BS-IV compliant preferably **PETROL vehicles**) having valid commercial registration, insurance, fitness, carriage permit and pollution control certificates along with proof of up to date tax payments
- Hiring Charges per month-Maximum **Rs.30,000/- excluding the fuel cost.**
- Minimum Average mileage of the vehicle is **10 kilometers per litre.**
- The vehicle will be engaged for full 30 days in a month.
- A licensed driver is to be provided along with the vehicle who should be well behaved, gentle, non alcoholic & obedient in nature.
- Vehicle should be kept clean with a clearly visible registration number and body sticking as specified in the contract of the vehicle.
- Vehicle will be stickered in front, back and side displaying different flagship programmes of the department.
- Vehicle should be regularly serviced & maintained so as to avoid any breakdown. In case of breakdown an alternative vehicle should be arranged by the owner without compromising the services of the MVU.
- The vehicle cannot be used for any private/commercial purpose beyond office hours or during holidays.
- Agreement will be made with the vehicle owners/service providers before engagement on yearly basis.
- In case of natural calamity like flood, cyclone, draught, lightening, heat wave, etc, outbreaks of disease, postmortem of insured livestock, MVU may be engaged.
- The undersigned shall have the right to terminate the agreement if the vehicle owner/service provider violates the agreement upon giving 1 month of notice.
- The MVU vehicle will remain in the VH/VD campus/HQ village at owner's risk.
- The interested vehicle owners are requested to apply to the undersigned in the specified format as in the advertisement.
- The sealed quotations completed in all aspects should reach the undersigned on or before date 29.06.2020 by 3.00 PM & shall be opened on date 30.06.2020 at 11.00AM in the presence of the bidders or their authorized representatives.
