OFFICE ORDER

Whereas the restrictions and regulations have been put in place to apply to the district of Jharsuguda in regard to the measures of containment of COVID vide this office order No.11418/Emg. Dated. 03.08.2020.

Whereas the District Disaster Management authority has the competence to take appropriate decision under the Disaster Management Act-2005 depending upon the contextual requirement

Whereas Para-12 of the order of the State in force allows the District Collector/ Municipal Commissioner to impose area specific reasonable restrictions in regard to activities outside the containment zones or such regulations as deemed necessary to contain the spread of COVID-19.

Whereas the provision of weekend shutdown as enunciated in this office Order No.11418/Emg. Dated.03.08.2020 is in force up to 16.08.2020.

Whereas this office Order No.11616/Emg. Dated.06.08.2020 stipulates that observance of Ganesh Puja and Nuakhai will be limited to households and rituals on the occasions will be performed at temples by the priests in the absence of devotees and it is necessary to allow space and time for the preparatory of the aforesaid festive occasions.

Whereas it is necessary that the Independence Day will be observed as per the allowed norms.

Now therefore in exercise of the authority conferred, the District Disaster Management Authority, Jharsuguda do hereby promulgate the following.

1. The weekend shutdown for 02 days i.e. Saturday and Sunday will continue up to **31.08.2020**.
2. Public movement will be allowed on 15.08.2020 from **7.00 AM to 11.00 AM** so as to enable the people to attend unfurling of flags. Heads of Office Establishments and Institutions including the educational ones will hoist the National Flag. The maximum attendance at all places including that of private organizations/units will be ten. Distancing will be maintained in the congregation. There will be no procession anywhere. Further the district function will be limited to invitees only.

3. On 22nd, August the market and shop establishments will remain open from **07.00 AM to 05.00 PM**. People will be allowed to procure articles for the festival from **07.00 AM to 05.00 PM**. Similarly on the day following i.e. 23rd, August the market will remain open from **07.00 AM to 01.00 PM**. However no pillion drive on motorcycle will be allowed.

All other provisions as incorporated in this office order No. 11418/Emg, Dated. 03.08.2020 will remain in force until 31.08.2020 or its eventual rescission.
