

**QUOTATION CALL NOTICE**

Sealed Quotations are invited from amongst the Nationalised Banks of Jharsuguda District selected by Government of Odisha, Finance Department vide letter No.24705 dated 20.07.2019 (copy enclosed) for parking of MPLADS funds in Savings Bank Account. The MPLADS funds are used for Development works based on the recommendations of the works made by the Members of Parliament. The selection of the Bank – Branch will be done by the authorized selection committee in accordance with the guidelines issued by Government of Odisha.

**General Instructions**

- (i) The filled in sealed quotation indicating a uniform rate of interest applicable for the parked funds may be submitted to the Office of the Deputy Director (P&S), District Planning & Monitoring Unit, Jharsuguda – 768204 on or before 15.09.2020 by 3:00 P.M. through registered post only.
- (ii) Nationalised Banks empanelled by Government of Odisha, Finance Department vide letter No.24705 dated 20.07.2019 will be eligible to participate in the quotation call.
- (iii) The Bank – Branch quoting maximum rate of interest shall be approved by the selection committee for parking of MPLADS funds.
- (iv) The rate on interest quoted shall remain valid for the duration of funds parked in the account and the nominated bank shall not be allowed to withdraw their offer subsequently.
- (v) The decision of the selection committee shall be final and binding.
- (vi) The selection committee has the right to accept or reject the Bank offer without mentioning any reason thereof.
