**Revised Boundary point of zone of containment (Map attached)**

The containment-zone shall comprise of the boundary as delineated below.

Containment "A"- A1 Think Food End→A2 Samaleswari Traders Back →A3 Beheramal HS Back  
→A4 Radhamadhab Mandir End.

Containment "B" – A5 Go Cool End→A6 Basti End →A7 Agharia pada Back →A8 Airtel Store end

Containment "C"- A9 Mamata Marbles End→A10 Kisan Chowk→A11 **Hotel Mid Town end**  
→A12 Goudpada End.

**Revised Boundary point of Buffer of containment (Map attached)**

The Buffer-zone shall comprise of the boundary as sketched below.

B1- Zisan Auto Care End→B2-Ganesh Apartment End → B3-Tulsi Mandir Bhuliatikra Bandh →B4  
Utkal Jyoti End.

The remaining part of the Order No.15098/Emg dt. 20.09.2020 will remain intact.
