In partial modification of this Office Order No.15110/Emg dt. 20.09.2020 pertaining to declaration of Containment zone in Sarbahal, Jharsuguda and in view of new cases of COVID-19 tested positive in cluster the following revised description in respect of the Zone of Containment and Buffer is made.

Revised Boundary point of zone of containment (Map attached)

The containment-zone shall comprise of the boundary as delineated below.

A1 Cape Town Front Entry Gate → A2 FCI SW → A3 Kisan Complex SW → A4 Kumbharpada NE → A5 Sarbahal Pond.

Revised Boundary point of Buffer of containment (Map attached)

The Buffer-zone shall comprise of the boundary as sketched below.

B1- Gokul Back Side → B2-Sarbahal Pond SW → B3-Sunarimunda Railway Crossing → B4 Prakash Enterprises Front.

The remaining part of the Order No. 15110/Emg dt. 20.09.2020 will remain intact.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
