Revised Boundary point of zone of containment (Map attached)

The containment-zone shall comprise of the boundary as delineated below.

A1 Used Car Shop → A2 Tanishq Show Room → A3 Basti End → A4 Radha Madhab Mandir Back → A5 Bank of india Back Side → A6 Kalinga Hotel End → A7 Utkal Jyoti Back Side → A8 Bandh End.

Revised Boundary point of Buffer of containment (Map attached)

The Buffer-zone shall comprise of the boundary as sketched below.

B1- Zisan Auto Care End → B2-Ganesh Apartment End → B3-Tulsi mandir Bhuliatikra Bandh → B4 Utkal Jyoti End.

The remaining part of the Order No.15098/Emg dt. 20.09.2020 and Order No.15313/Emg dt. 22.09.2020 will remain intact.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
