OFFICE ORDER

No. 3193 /Emg.

/Dated: 01.04.2021

Whereas the Govt. of Odisha in Revenue & Disaster Management Department (DM) have issued Order No. 1663/R&DM(DM) dt 31.03.2021 for surveillance, containment and caution with regard to COVID-19, to remain in force in the state until the midnight of 30.04.2021.

And Whereas para 1 (i) 2 (ii), 2(vii), 3 (i)(d), 3 (iii)(b), 3 (iii)(f), 3 (v), 3 (xii), 3 (xiv), 3 (xv) and 9 of the Order of the State allows the District Collectors/Municipal Commissioners to take decision on certain activities outside the Containment Zones or such regulations as deemed necessary to contain the spread of COVID-19.

Now therefore in exercise of the authority conferred, we promulgate the following district specific guidelines to apply to the district of Jharsuguda until the midnight of 30.04.2021, save eventual revisions which may be occasioned later.

1. The Order will be treated supplemental to the Order of the State(enclosed) that allowed variations, in so far it relates to the Revenue Jurisdiction of Jharsuguda district.
2. BDOs and EOs will generate public awareness through loud speaker announcement and other means in local communities on COVID-19 appropriate behavior.
3. IICs of the Local Police Stations are authorised to accord necessary permission within the ceiling prescribed for Social / religious / political / sports / entertainment / academic /cultural functions / gathering. The gathering on social occasion including marriage will be limited to 200 and for performance of funeral rites the allowed congregation will be maximum 50. IICs of the Local Police Stations will accord permission for all the purposes.
4. Order Earlier issued Vide No. 3086/emg dt. 30.03.2021 (copy enclosed) on observance of 'Utkal Divas' will remain in force.

5. Order Earlier issued Vide No. 3081/emg dt. 30.03.2021 (copy enclosed) on celebration of 'Good Friday', 'Easter', 'Pana Sankranti', 'Jhamu Yatra', 'Danda Yatra' and 'Sriram Navami' will remain in force.
6. Business to Business (B2B) and Business to Consumers(B2C) exhibition with restrictions as stipulated in the order of Govt. of Odisha are allowed. However Sub-Collector, Jharsuguda is authorised to issue necessary permission in this regard.
7. Public worship at religious places / such institutions of different sects in the district shall continue with the stipulations mentioned in this Office Order No. 235/Emg dt. 11.01.2021 **(copy enclosed)**.
8. Functioning of open Air Theatre/Jatras/Operas/Merry-go-round(Doli)/Meena Bazar is allowed. However, the Sub-Collector, Jharsuguda will issue permission and such activities will be subject to compliance of safety protocols to be mentioned in the letter of permission.
9. The shop keepers and vendors will operate from 7.00 AM to 8.00 PM. They will ensure social distancing and wearing of masks by customers and will not sell articles to buyers, not wearing mask.
10. All the Govt. offices shall function as per Govt. of Odisha in G.A & P.G Department's Order No. 3393/GEN dt. 29.01.2021. **(copy enclosed)**.
11. The following categories of the people are advised against outdoor movement except for essential and health purposes.
 - a. Persons above 65 years of age.
 - b. Pregnant Women
 - c. Children below the age of 10 years


The heads of respective families will be liable for penal action in case of unnecessary outdoor movement by the above category persons.





ORDER

Whereas, resurgence of SARS CoV-2 has been noticed in many parts of India and some areas of the State;

And whereas, COVID appropriate behavior and protocols are required to be observed scrupulously in order to prevent the transmission of the infection;

And whereas, Ministry of Home Affairs, Government of India (GoI) has issued guidelines vide Order No.40-3/2020-DM-I(A) dated 23rd March,2021 for effective control of COVID-19 to be effective from April 1st, 2021;

Now therefore, in exercise of the powers, conferred under Section 24(l) of the Disaster Management Act 2005, read with Rule 8(1) of the Odisha Disaster Management Rules, 2010, the undersigned hereby directs that following guidelines shall be in force in the State of Odisha from **01.04.2021 to 30.04.2021**:

1. Surveillance and Containment

- I. Local Authorities i.e., District Collector/ Municipal Commissioner shall carefully demarcate the containment zones, at the micro level in accordance with the guidelines of MoHFW, Government of India/ H&FW Department, Government of Odisha. The Containment Zones will be notified by the respective District Collectors/ Municipal Commissioners and information will be shared with MoHFW. The notification shall be uploaded by the District Collector and by the State on their websites.
- II. With the detection of new positive cases, Containment measures, as prescribed by MoHFW, Government of India/ H&FW Department, Government of Odisha, shall be scrupulously followed in the containment zones.
- III. Awareness shall be created in communities on COVID-19 appropriate behavior.

2. Testing, Tracking and Treatment

- I. Testing shall be carried out as per prescribed protocol. The proportion of RT-PCR tests in the total mix should be scaled up to the extent possible.
- II. Effective demarcation of containment zones, in vulnerable and high incidence areas, is key to breaking the chain of transmission and hence critical to containing the

spread of the virus. Therefore, District/ Municipal Authorities shall carefully demarcate Containment Zones as per the Guidelines of MoHFW/ H&FW Department, Government of Odisha. The list of such containment zones will be notified on the websites of MoHFW by the respective District Collectors and Municipal Commissioners and by the H&FW Department.

- III. Containment measures, as prescribed by MoHFW/ H&FW Department of Government of Odisha, shall be scrupulously followed in the demarcated Containment Zones.
- Only essential activities shall be allowed.
 - There shall be strict perimeter control to ensure that there is no movement of people in or out of these zones, except for medical emergencies and for maintaining supply of essential goods and services.
 - There shall be intensive house-to-house surveillance by surveillance teams.
 - Listing of contacts shall be carried out in respect of all persons found positive, along with their tracking, identification, quarantine and follow up of contacts for 14 days (80% of contacts to be traced in 72 hours).
 - Surveillance for ILI/ SARI cases shall be carried out in health facilities or outreach mobile units or through fever clinics in buffer zones.
- IV. Quick isolation of COVID-19 patients shall be ensured in treatment facilities/ home (subject to fulfilling the home isolation guidelines).
- V. Clinical interventions and clinical Management protocol, as prescribed/ required shall be clearly understood and administered.
- VI. Effective infection, prevention and control practices shall be followed in treatment facilities and by health care workers and professionals.
- VII. Awareness shall be created in communities on COVID-19 appropriate behavior.

The District Administration, Police and Municipal Authorities shall ensure that the prescribed *containment measures* are strictly followed.

Vaccination - Health and Family Welfare Department, Government of Odisha shall ensure implementation of the guidelines of vaccination drive of Government of India.

Covid Appropriate Behaviour- The District/ Municipal Authorities/ Police Commissioner, Bhubaneswar-Cuttack shall ensure strict compliance of Covid appropriate behaviour, such as use of face masks, maintaining physical distancing and hand hygiene. Crowd shall be regulated in all busy market places, weekly haats, public transport and other places. Any violation/ non-compliance of MHA (National Directives as specified in (**Annexure-I**)/ State Government directives/ guidelines in this regard shall be strictly dealt with.

3. Regulation of activities in areas outside the Containment Zones

- i. Large gatherings, congregations shall continue to be prohibited. Social/ religious/ political/ sports/ entertainment/ academic/ cultural functions and gatherings shall be allowed with a ceiling of 200 persons subject to the following conditions:
 - a. In closed spaces, a maximum of 50% of the hall capacity will be allowed subject to the above ceiling.

- b. In open spaces, keeping the size of the ground/ open space in view, appropriate number of persons will be allowed, within the ceiling prescribed above, so as to ensure maintenance of prescribed physical distancing norms.
 - c. Wearing of masks, maintaining social distancing and provision of thermal scanning & use of hand wash or sanitizer will be mandatory.
 - d. Permission for such functions/ gatherings shall be accorded by the respective District Magistrates/ Municipal Commissioners or other officers authorised by them.
- ii. However, in view of the Bye-election to the 110- Pipili Assembly Constituency in Puri district announced by the Election Commission of India to be held on 17th April, 2021, political meetings and other functions/ gatherings in connection with the said Bye-election, as permitted by the ECI/ CEO, Odisha or the empowered/ authorised officers on that behalf, shall be allowed within the jurisdiction of the said Assembly Constituency only subject to the following conditions:
 - a. In closed spaces, a maximum of 50% of the hall capacity will be allowed, with a ceiling of 200 persons. Wearing of masks, maintaining social distancing, provision of thermal scanning and use of hand wash or sanitizer will be mandatory.
 - b. In open spaces, keeping the size of the ground/ open space in view, the District Administration shall give permission for gathering for such number of persons as would be appropriate ensuring strict observance of physical distancing norms. Wearing of masks, provision of thermal scanning and use of hand wash or sanitizer will be mandatory.
 - c. The District Magistrate-cum-District Election Officer/ authorized officer shall ensure strict enforcement of the conditions for holding the political meetings and other functions/ gatherings in connection with the said bye-election.
- iii. In view of celebration of several social, religious and cultural events, such as, Utkal Divas, Good Friday, Ram Navami, Maha Bishuba Sankranti, JhammuJatra etc. in different parts of the State during the month of April, the following guidelines shall be strictly followed in the interest of the general public and for containment of spread of COVID-19;
 - a. Congregation for celebration of the above festivals and associated religious and cultural congregations shall not be allowed in public throughout the State.
 - b. Religious rituals in churches/ temples/ places of worship including in places where such rituals are performed traditionally will continue as usual with limited number of persons as permitted by the District Collector/ Municipal Commissioner or any officer duly authorised by him/her with strict adherence to Covid protocols.
 - c. Large congregation for celebration of 'Utkal Divas' and associated cultural programmes shall not be allowed throughout the State.
 - d. The official meeting/ celebration of Utkal Divas shall be made with a maximum of 200 participants. COVID- 19 safety protocols like social distancing, use of

- masks, use of soap & water/ sanitizer shall be strictly adhered to. Other activities during the day shall be avoided.
- e. Other organizations & private institutions shall observe 'Utkal Divas' and related activities with prior approval from the local Administration i.e., Collector or Municipal Commissioner or any officer duly authorised by the Collector/ Municipal Commissioner subject to the above ceiling and strictly adhering to COVID- 19 safety protocols.
 - f. The Departments/ Collectors shall issue instructions to the field offices for observance of the occasion with above ceiling and with strictly adherence to COVID- 19 safety protocols.

Considering local conditions, Collectors and Municipal Commissioners may impose appropriate restrictions on celebration and entry of devotees into churches/ temples/ religious places/ places of worship. Further, Collectors/ Municipal Commissioners may decide the number of persons to attend any such religious ritual/ festival in their respective jurisdictions with strict adherence to Covid appropriate behaviour and norms.

- iv. Marriage, funeral/ last rites related gatherings shall be allowed with a ceiling of 200 and 50 persons respectively, subject to the following conditions:
 - a. In closed spaces, a maximum of 50% of the hall capacity will be allowed subject to the above ceilings.
 - b. In open spaces, keeping the size of the ground/ open space in view, appropriate number of persons will be allowed, subject to the above ceilings, so as to ensure maintenance of prescribed physical distancing norm.
 - c. Wearing of masks, maintaining social distancing and provision of thermal scanning & use of hand wash or sanitizer will be mandatory.
 - d. The host of the marriage/ funeral function shall make necessary arrangement for checking at the entry point and ensure wearing of mask by the guests/ others during the entire duration of their participation. The Host shall make arrangement to provide masks to those who have not come with appropriate mask. The Guidelines issued by the State Government vide Order No.4014/R&DM(DM) dated 06.07.2020 (***Annexure-II***) for marriage and funeral related functions during COVID-19 pandemic shall be strictly followed with the above modifications.
- v. Business to Business (B2B) and Business to Consumers (B2C) exhibitions shall be allowed in exhibition halls with participants/ visitors up to 50% of the hall capacity complying with the COVID-19 safety protocols. In open spaces, keeping the size of the ground/ open space in view, appropriate number of persons will be allowed at any point of time so as to ensure maintenance of prescribed physical distancing norm. Permission for such exhibitions shall be accorded by the respective District Magistrates/ Municipal Commissioners or other officers authorised by them.

- vi. All Medical Colleges of the State have been allowed to reopen with effect from 1st December, 2020. Medical College Authorities shall follow all the SOPs /guidelines with respect to social distancing and prevention of spread of epidemic issued by Central/ State Government, scrupulously.
- vii. The Department of School & Mass Education/ ST & SC Development, Minorities and Backward Classes Welfare Department/ Department of Social Security & Empowerment of Persons with Disabilities is authorised to take appropriate decision with regard to the date of re-opening of schools and hostels under its control/ superintendence/ supervision in respect of classes from 9th to 12th Standard in a graded manner observing necessary guidelines/ SOP developed for the purpose. The Department shall further develop detailed SoP for the primary schools and decide on opening of such schools with approval of Government.
- viii. Government in School and Mass Education Department has allowed physical classes for Standard 9 and Standard 11. Considering the present situation, the School & Mass Education Department may allow conduct of intra-school class promotion examination for 9th and 11th Standards giving the option of online examination to the students with consent of their parents/ guardians.
- ix. The Department of Higher Education is authorized to take appropriate decision with regard to the date of re-opening of Colleges/ Higher Education Institutions and Hostels under its control/ superintendence/ supervision by following the guidelines/ SOP issued by the Department/ UGC/ AICTE/ Ministry of Home Affairs, Government of India.
- x. The Department of Skill Development and Technical Education is authorised to take appropriate decision with regard to the date of re-opening of Engineering Colleges and other Technical Education/ Skill Development Institutions and Hostels under its control/ superintendence/ supervision in a graded manner in compliance with the Guidelines/ SOP issued by the Department/ UGC/ AICTE/ Ministry of Home Affairs, Government of India.

Notwithstanding closure of Academic/ Technical/ Skill Development Institutions, the followings will be permitted:

- a. Conduct of examinations (including academic, competitive and entrance tests), evaluation and other administrative activities.
- b. Online/ distance learning shall continue to be permitted and shall be encouraged.
- c. The concerned department may permit teaching and non-teaching staff to be called to the School/ College/ Institution for online teaching/ tele-counselling and related work, in areas outside the Containment Zones only as per Standard Operating Procedure (SOP) issued by the Ministry of Education/ Health & Family Welfare (MoHFW), GoI.
- d. All training activities including skill and professional development.
 - xi. Anganwadi Centres have been allowed to function with effect from 1st February, 2021.
 - xii. Local Authority i.e., District Magistrate/ Municipal Commissioner are authorised to permit public worship in religious places/ places of worship with appropriate

restrictions, based on local assessment of the situation with regard to spread of COVID-19 and in due consultation with relevant stakeholders, with observance of COVID-19 safety protocol.

- xiii. Cinema Halls/ Theatres shall be allowed to open and operate with 50% of hall *capacity*. Entertainment Parks shall operate within the ceiling on gathering in open space/ public spaces. All such activities shall be conducted as per SOP issued by the Government in that regard.
- xiv. Open Air Theatres/ Jatras/ Operas shall be permitted by the local authorities (District Magistrate/ Municipal Commissioner or any other officer authorized) subject to compliance of COVID-19 safety protocols such as mandatory wearing of face masks, physical distancing, provision of thermal scanning, etc. Keeping the size of the ground/ space in view, appropriate number of persons (subject to a ceiling of 2000 persons) will be allowed ensuring maintenance of prescribed physical distancing norm i.e., maintaining a distance of 6 feet from each other and the seating arrangement shall be made accordingly. Persons with Influenza like Infection (ILI)/ Severe Acute Respiratory Infection (SARI)/ COVID-19 like symptoms shall not be allowed. As far as possible, facility for online booking of tickets may be arranged by the organizers and sufficient number of counters shall be opened to prevent crowding during physical booking of tickets. Facility of advance booking online as well as through counters may also be organized. The organizers shall be responsible for due compliance of these norms/ conditions.
- xv. Merry-go-round (Doli)/ Meena Bazaar and related activities shall be permitted by local authorities, i.e. District Magistrate/ Municipal Commissioner/ authorized officer subject to complying with the COVID-19 appropriate behavior and safety protocols.
- xvi. Opening and use of Swimming Pools shall be as per the SOP issued/ to be issued by Ministry of Youth Affairs & Sports, GoI.
- xvii. International air travel of passengers shall be as decided by the Ministry of Civil Aviation/ Ministry of Home Affairs, GoI.

Subject to other provisions of this order, activities that are not specifically prohibited/ regulated/ restricted above are allowed subject to adherence to safety and health protocols and SOPs/ guidelines issued by appropriate authorities.

4. Use of AarogyaSetu

Use of *AarogyaSetu* may continue on best effort basis on compatible mobile phones. This will facilitate timely provision of medical attention to those individuals who are at risk.

5. General Directives for COVID-19 Management

The following General Directives for COVID-19 Management shall be strictly followed throughout the State:

- a. Face coverings/ Masks: Wearing of face cover/ mask properly is compulsory in public places; in workplaces; and in public transport (**Annexure-III**).
- b. Physical distancing: Individuals must maintain a minimum distance of 6 feet in public places.
- c. Shops and Commercial Establishments will ensure physical distancing and use of face cover/ mask by employees and customers. The onus of compliance to the guideline lies with the owner of the shop/ commercial establishment, who shall be liable for any violation which may lead to penal action including closure/ sealing of the premises.
- d. Salons, Spas, Beauty Parlours and Barber shops shall ensure all safety precautions, disinfection and sanitization before and after service of each customer. The onus of compliance to the guideline lies with the owner, who shall be liable for any violation, which may lead to penal action including closure/ sealing of the premises.
- e. Spitting in public place will be punishable with fine, as prescribed in accordance with laws, rules or regulations (**Annexure-IV**).
- f. Same as permitted by the Excise Department, consumption of liquor in public place is prohibited.
- g. Consumption of paan, gutka, tobacco, and similar products in public place is prohibited.

6. Movement of persons and goods

There shall be no restriction on inter-State and intra-State movement of persons, private vehicles and goods including those for cross land-border trade under Treaties with neighbouring countries. No separate permission/ approval/ e-permit will be required for such movements.

7. Permitted activities to be performed following prescribed SOPs

Activities allowed/ to be allowed under these Guidelines shall be performed in accordance with appropriate Guidelines/ SOPs issued by the Central/ State Government from time to time. Web-link/ URL of some of these SOPs issued by the Government of India are available at **Annexure-V**.

8. Safety and Protection of vulnerable persons

The following categories of people are advised against outdoor movement, except for essential and health purposes.

- a. Persons above 65 years of age
- b. persons with co-morbidities
- c. pregnant women
- d. children below the age of 10 years


9. Strict enforcement of the guidelines

All the District Magistrates/ Municipal Commissioners/ Commissioner of Police, Bhubaneswar-Cuttack shall strictly enforce the above measures.

10. Penal provisions


Any person violating these measures will be liable to be proceeded against in accordance with the provisions of Section 51 to 60 of the Disaster Management Act, 2005, the Epidemic Diseases Act, 1897 and Regulations issued thereunder besides legal action under Section 188 of the IPC and other legal provisions as applicable. 



NATIONAL DIRECTIVES FOR COVID-19 MANAGEMENT


1. **Face coverings:** Wearing of face cover is compulsory in public places; in workplaces; and during transport.
2. **Social distancing:** Individuals must maintain a minimum distance of 6 feet (2 gaz ki doori) in public places.

Shops will ensure physical distancing among customers.

3. **Spitting in public places** will be punishable with fine, as may be prescribed by the State/ UT local authority in accordance with its laws, rules or regulations.

Additional directives for Work Places

4. **Work from home (WfH):** As far as possible the practice of WfH should be followed.
5. **Staggering of work/ business hours** will be followed in offices, work places, shops, markets and industrial & commercial establishments.
6. **Screening & hygiene:** Provision for thermal scanning, hand wash or sanitizer will be made at all entry points and of hand wash or sanitizer at exit points and common areas.
7. **Frequent sanitization** of entire workplace, common facilities and all points which come into human contact e.g. door handles etc., will be ensured, including between shifts.
8. **Social distancing:** All persons in charge of work places will ensure adequate distance between workers and other staff.



GUIDELINES FOR MARRIAGE AND FUNERAL RELATED FUNCTIONS DURING COVID-19 PANDEMIC

A. Marriage and related functions

1. Marriage and its related functions shall be held only with prior permission (in writing or through electronic communication) of the local Police Station.
2. Local Police Station will be authorised to give permission for holding marriage and its related functions subject to participation of maximum 50 (Fifty) persons.
3. **There will be no marriage procession until further orders.**
4. Total participants in the marriage function at the **marriage venue** including groom, bride, family members of groom & bride, friends, relatives, guests, priests, personnel of support services like food preparation and distribution, etc. **put together** will not exceed 50 (fifty) cumulatively.
5. Local police authorities will ensure that under no circumstances more than 50 persons participate in the marriage ceremony.
6. Other permissions, if any required, shall be obtained from the competent authority (ies) and conditions therein shall be complied with.
7. Persons with symptoms of Influenza Like Infection (ILI) and Severe Acute Respiratory Infection (SARI) shall not be allowed to the marriage venue/ function.
8. Vulnerable groups of people, such as, persons above 65 years of age, children below 10 years, persons with co-morbidities and pregnant women are advised not to attend the function.
9. At least 2 meter physical distance shall be maintained between individuals during marriage function.
10. All persons in the marriage venue shall mandatorily use face mask during the entire period of the function except during eating.
11. Chewing of gutka and paan and spitting in public is strictly prohibited. The father / guardian of the groom shall ensure adherence to this.
12. The host of the marriage will ensure elaborate arrangement for hand washing with soap and water and also ensure availability of hand sanitizers.

13. The seating and dining arrangement shall be done in such a way that at least 2 metre physical distance is maintained between individuals.

Liability for violation, if any:

1. The host and the owner/ manager of the marriage venue/ premises shall be held responsible for ensuring the guidelines and will be liable for legal action in case of any violation.
2. The participants in the marriage function will also be held responsible for violation of conditions, if any, on their part and shall be liable for legal action.

B. Funeral and related functions

1. Funeral and its related functions shall be held with prior permission (in writing or through electronic communication) of the local Police Station.
2. However, cremation can be carried out under intimation to the local police station in writing or through electronic communication. Where the cremation is to be done at a place within the area of a police station other than the police station area in which the death has occurred, intimation has to be given to both the police stations.
3. The number of persons participating in the funeral function including the family members, relatives, friends, priests, drivers & staff of vehicles and others **taken together** shall not exceed 20 (Twenty).
4. At least 2 meter physical distance shall be maintained between individuals in the funeral function.
5. The seating and dining arrangement shall be done in such a way that at least 2 metre physical distance is maintained between individuals.
6. All persons participating in the funeral function shall mandatorily use face mask during the entire period of activities except during eating/ bathing.
7. Chewing of gutka and paan and spitting in public is strictly prohibited. The host of the funeral function shall ensure adherence to this.
8. No vehicle used in the procession shall carry persons beyond its seating capacity.
9. The hosts of the funeral ceremony will ensure elaborate arrangement for hand washing with soap and water and also ensure availability of hand sanitizers.

10. It will be the responsibility of the host of the funeral function to ensure that the provisions of these guidelines are strictly followed including the ceiling on the number of persons to attend the funeral ceremony.
11. The owner/ manager of the premises of the funeral function shall also be held responsible for ensuring the guidelines in the premises and liable for legal action in case of any violation.

In exercise of the powers conferred by sections 2 and 3 of the Epidemic Diseases Act, 1897 (3 of 1897), the State Government do hereby make the following regulations to amend the Odisha COVID-19 Regulations, 2020 issued under the notification of the Government of Odisha in the Health and Family Welfare Department No. HFW-SCH-I-EMER-0001-2020 9570/H dated the 3rd April, 2020, namely:-


1. These regulations may be called The Odisha COVID-19 (Amendment) Regulations, 2020.
2. In the Odisha COVID-19 Regulations, 2020 (hereinafter referred to as the said Regulations), after regulation 4, the following regulation shall be inserted, namely:-

"4 – A. Use of Mask:

- (a) All persons shall cover their mouth and nose with any available form of mask while coming out of house for any purpose. A handkerchief or any other piece of cloth in at least two layers can also be used for the purpose.
- (b) All officers not below Extension Officers of the Block or all officers not below Additional Tahsildars or all police officers not below Assistant Sub-Inspector of Police or all officers of Urban Local Bodies not below the Ward Officer are authorized to ensure prevention of crowding and also ensure use of any form of masks or clothes such as handkerchiefs, bandanas, gamuchha, dupatta or the like by the people, while coming out of their house.
- (c) Disposable or single use masks shall be properly disposed of by following due procedure prescribed by the Health & Family Welfare Department, from time to time. Cloth masks should be cleaned with soap or detergent or disinfectant and water and those shall be sun dried for at least 5 hours after every single use.

- (d) Masks used by one person shall not be used by any other person.
- (e) The use of mask by all persons shall be mandatory with effect from 7 am of 9th April, 2020.
3. In the said Regulations, in regulation 8 (i) for the words and brackets "the section 188 of the Indian Penal Code (48 Of 1860)", the words and brackets "section 3 of the Epidemic Diseases Act, 1897 as amended by the Epidemic Diseases (Amendment) Ordinance, 2020" shall be substituted.
4. In the said Regulations, after regulation 8, the following regulation shall be inserted, namely:-
- "8 – A. Procurement: To meet the urgency during the outbreak of the epidemic disease, the State Government may procure goods, services and equipments necessary for prevention and control of the epidemic disease dispensing with the rules, regulations, orders or notifications in force regulating such procurement."
5. In the said Regulations, in regulation 10(penalty), for the words and brackets "punishable under section 188 of Indian Penal Code (45 of 1860)", the words and brackets "punishable under section 3 of the Epidemic Diseases Act, 1897, as amended by the Epidemic Diseases (Amendment) Ordinance, 2020" shall be substituted.
6. In the said Regulations, after regulation 10, the following regulation shall be inserted, namely:-
- "10–A. For violation of the provisions regarding Use of Mask contained in Regulation 4 – A, all officers not below Extension Officers of the Block or all officers not below Additional Tahsiildar or all police officers not below Assistant Sub-Inspector of Police or all officers of Urban Local Bodies not below the Ward Officer shall compound the offence on payment of rupees two hundred for the first, second and third offence and on payment of five hundred rupees for the subsequent offences.

Offences and Penalties for Violation of Lockdown Measures

A. Section 51 to 60 of the Disaster Management Act, 2020

51. Punishment for obstruction, etc.—Whoever, without reasonable cause —

- (a) obstructs any officer or employee of the Central Government or the State Government, or a person authorised by the National Authority or State Authority or District Authority in the discharge of his functions under this Act; or
- (b) refuses to comply with any direction given by or on behalf of the Central Government or the State Government or the National Executive Committee or the State Executive Committee or the District Authority under this Act.

shall on conviction be punishable with imprisonment for a term which may extend to one year or with fine, or with both, and if such obstruction or refusal to comply with directions results in loss of lives or imminent danger thereof, shall on conviction be punishable with imprisonment for a term which may extend to two years.

52. Punishment for false claim.—Whoever knowingly makes a claim which he knows or has reason to believe to be false for obtaining any relief, assistance, repair, reconstruction or other benefits consequent to disaster from any officer of the Central Government, the State Government, the National Authority, the State Authority or the District Authority, shall, on conviction be punishable with imprisonment for a term which may extend to two years, and also with fine.

53. Punishment for misappropriation of money or materials, etc.—Whoever, being entrusted with any money or materials, or otherwise being, in custody of, or dominion over, any money or goods, meant for providing relief in any threatening disaster situation or disaster, misappropriates or appropriates for his own use or disposes of such money or materials or any part thereof or wilfully compels any other person so to do, shall on conviction be punishable with imprisonment for a term which may extend to two years, and also with fine.

54. Punishment for false warning.—Whoever makes or circulates a false alarm or warning as to disaster or its severity or magnitude, leading to panic, shall on conviction, be punishable with imprisonment which may extend to one year or with fine.

55. Offences by Departments of the Government.—(1) Where an offence under this Act has been committed by any Department of the Government, the head of the Department shall be deemed to be guilty of the offence and shall be liable to be proceeded against and punished accordingly unless he proves that the offence was committed without his knowledge or that he exercised all due diligence to prevent the commission of such offence.

(2) Notwithstanding anything contained in sub-section (1), where an offence under this Act has been committed by a Department of the Government and it is proved that the offence has been committed with the consent or connivance of, or is attributable to any neglect on the part of, any officer, other than the head of the Department, such officer shall be deemed to be guilty of that offence and shall be liable to be proceeded against and punished accordingly.

56. Failure of officer in duty or his connivance at the contravention of the provisions of this Act.—Any officer, on whom any duty has been imposed by or under this Act and who ceases or refuses to perform or withdraws himself from the duties of his office shall, unless he has obtained the express written permission of his official superior or has other lawful excuse for so doing, be punishable with imprisonment for a term which may extend to one year or with fine.

57. Penalty for contravention of any order regarding requisitioning.—If any person contravenes any order made under section 65, he shall be punishable with imprisonment for a term which may extend to one year or with fine or with both.

58. Offence by companies.—(1) Where an offence under this Act has been committed by a company or body corporate, every person who at the time the offence was committed, was in charge of, and was responsible to, the company, for the conduct of the business of the company, as well as the company, shall be deemed to be guilty of the contravention and shall be liable to be proceeded against and punished accordingly:

Provided that nothing in this sub-section shall render any such person liable to any punishment provided in this Act, if he proves that the offence was committed without his knowledge or that he exercised due diligence to prevent the commission of such offence.

(2) Notwithstanding anything contained in sub-section (1), where an offence under this Act has been committed by a company, and it is proved that the offence was committed with the consent or connivance of or is attributable to any neglect on the part of any director, manager, secretary or other officer of the company, such director, manager, secretary or other officer shall also, be deemed to be guilty of that offence and shall be liable to be proceeded against and punished accordingly.

Explanation.—For the purpose of this section—

(a) "company" means anybody corporate and includes a firm or other association of individuals; and

(b) "director", in relation to a firm, means a partner in the firm.

59. Previous sanction for prosecution.—No prosecution for offences punishable under sections 55 and 56 shall be instituted except with the previous sanction of the Central Government or the State Government, as the case may be, or of any officer authorised in this behalf, by general or special order, by such Government.

60. Cognizance of offences.—No court shall take cognizance of an offence under this Act except on a complaint made by—

(a) the National Authority, the State Authority, the Central Government, the State Government, the District Authority or any other authority or officer authorised in this behalf by that Authority or Government, as the case may be; or

(b) any person who has given notice of not less than thirty days in the manner prescribed, of the alleged offence and his intention to make a complaint to the National Authority, the State Authority, the Central Government, the State Government, the District Authority or any other authority or officer authorised as aforesaid.

B. Section 188 in the Indian Penal Code, 1860

188. Disobedience to order duly promulgated by public servant.— Whoever, knowing that, by an order promulgated by a public servant lawfully empowered to promulgate such order, he is directed to abstain from a certain act, or to take certain order with certain property in his possession or under his management, disobeys such direction, shall, if such disobedience causes or tends to cause obstruction, annoyance or injury, or risk of obstruction, annoyance or injury, to any person lawfully employed, be punished with simple imprisonment for a term which may extend to one month or with fine which may extend to two hundred rupees, or with both; and if such disobedience causes or tends to cause danger to human life, health or safety, or causes or tends to cause a riot or affray, shall be punished with imprisonment of either description for a term which may extend to six months, or with fine which may extend to one thousand rupees, or with both. *Explanation.*—It is not necessary that the offender should intend to produce harm, or contemplate his disobedience as likely to produce harm. It is sufficient that he knows of the order which he disobeys, and that his disobedience produces, or is likely to produce, harm.

Illustration

An order is promulgated by a public servant lawfully empowered to promulgate such order, directing that a religious procession shall not pass down a certain street. A knowingly disobeys the order, and thereby causes danger of riot. A has committed the offence defined in this section.

Whereas the State Government Vide Order No. 1020/R&DM(DM) dt 27.02.2021 have specifically directed that large gatherings congregations shall continue to be prohibited.

And whreas, the Govt. of Odisha Vide their Order No. 1635/R&DM(DM) dt 26.03.2021 have limited the observance of 'Utkal Divas' and related activities on 1st April 2021 for the sake of containing the out break and spread of new variant of SARS-Cov-2.

We do hereby issue the following stipulations to apply to the district of Jharsuguda.

- a. There will be no large Congregation for celebration of 'Utkal Divas' and associated cultural programmes.
- b. The official meeting / celebration of 'Utkal Divas' shall be made with a maximum of 200 participants. COVID-19 safety prorocols like social distancing, use of masks, use of soap and water /sanitizers shall be strictly adhered to.
- c. There will be no other activities related to observance 'Utkal Divas'.
- d. Other Organizations and private institutions willing to observe 'Utkal Divas' shall take prior permission from the Local Police Stations subject adhere to COVID-19 safety protocols.

The Tahasildars as incident Commanders are hereby authorised to implement the above restrictions in their respective jurisdictions.

Persons found violating this order shall be punished under the provisions of Disaster Management Act 2005 and other relevant laws.



Whereas the State Government Vide Order No. 1020/R&DM(DM) dt 27.02.2021 have specifically directed that large gatherings congregations shall continue to be prohibited.

And whereas, the sacred festivals of 'Good Friday', 'Easter', 'Pana Sankranti' /'Jhamu Yatra', 'Danda Yatra' and 'Sriram Navami' etc are falling in the month of April and people usually congregate and get in touch with each other to celebrate the festivals during which it is not possible to adhere to COVID appropriate behaviour and such congregations have a potential to cause spread of new variant of SARS-Cov-2.

We do hereby issue the following stipulations to apply to the district of Jharsuguda.

- a. There will be no public celebrations for the festival like 'Good Friday', 'Easter', 'Pana Sankranti' / 'Jhamu Yatra', 'Danda Yatra' and 'Sriram Navami' etc.
- b. Devotees can visit temples/churches and worship as usual with limited numbers following social distancing and compulsory wearing of masks only.
- c. There will be no gathering at any public place.

The Tahasildars as incident Commanders are hereby authorised to implement the above restrictions in their respective jurisdictions.

Persons found violating this order shall be punished under the provisions of Disaster Management Act 2005 and other relevant laws.

Whereas the Govt. of Odisha in Revenue & Disaster Management Department (DM) Vide Order No. 7384/R&DM(DM) dt 30.12.2020 have been pleased to delegate power to the Local authority i.e the District Magistrate to permit public worship in religious places/places of worship with appropriate restriction based on local assessment of the situation and regard to spread of COVID-19 with strict observance of COVID-19 safety Protocols.

And Whereas the District Authority has decided vide Order No. 19494/Emg dt.31.12.2020 that public worship in religious places/ at such institutions different sects shall start in the district from 11th January 2021 if the prevalent situation does not demand otherwise.


And Whereas the District Authority, after assessment of prevalent situation in the district is satisfied that all religious institutions/places of Worship in the district should be opened for public subject to adherence to COVID-19 guideline and necessary precautions.

Now therefore in exercise of the authority conferred, I Saroj Kumar Samal, OAS, Collector & DM, Jharsuguda Promulgate the said guidelines for public worship at religious places/ such institutions of different sects in the district of Jharsuguda, save eventual revision which may be occasioned later.

Public worship at religious places/ such institutions of different sects in the district of Jharsuguda is allowed w.e.f 11.01.2021 subject to the following stipulations.

1. It is mandatory for all devotees to wear masks at all times inside and outside the religious institutions /places of worship.
2. Devotees should sanitize their hands before entering into respective religious institutions /places of worship.
3. Devotees should maintain physical distance as per COVID guidelines.
4. Touching of Idols and statues is prohibited.


5. It is not allowed to take flowers / Prasad / other related materials for worship inside these institutions /places of worship.
6. Chewing of Tobacco/Gutka & spitting inside the religious institutions /places of worship is prohibited.
7. Persons above 65 years of age, and with co-morbidities, pregnant women & children below 10 years are advised not to visit the places of worship/prayer.
8. Sanitization of the religious institutions /places of worship is to be done at least twice a day.
9. A minimum number of devotees should be allowed inside the Temple/Gurudwara/Masjid/Church keeping in view the availability of space on such premises and the need to maintain physical distance.
10. Proper arrangement should be there in Bhoga mandap /prayer hall so that physical gap can be maintained among the devotees.
11. Phased entry need to be done in order to ensure thin presence at one point of time.
12. No singing or prayer in groups is allowed.
13. There should be no use of common mat.
14. Provision should be made for separate entry and exit.
15. No cultural activity / program will be allowed on the premises.
16. At the entry there will be oval/circle shaped marking on the ground for devotees to stand in queue in case there is rush.
17. A public notice bearing above stipulations shall be displayed at conspicuous points of such religious institutions /places of worship.
18. Anyone violating the COVID-19 safety protocols during the visit to religious institutions /places of worship will be liable for penal action. Liability will be open to be fixed upon the stakeholders who will include priests/ Maulvi/Father/Devotees irrespective of sect.
