Sealed tender in the prescribed format is invited again by the under signed with reference to this office earlier Notice 361/ Agril. Dt.05.07.2019 for the auction sale of "Mahindra C.J 500-D.E 14W-Diesel jeep bearing registration no. **OR 15 1299**" of this O/o. The Agriculture District Officer, Kolabira as is where basis. The intending tenderers/bidder may inspect the vehicle in the premises of the undersigned on any working day during office hours. The tender paper should accompany with Earnest Money of Rs.2000/- (Rupees Two Thousand) only in shape of Bank Draft drawn in favour of The Agriculture District Officer, Kolabira payable at State Bank of India, Main Branch, Jharsuguda. No tender shall be entertained unless it is accompanied with the Earnest Money. The Earnest Money received from the tenderers shall not bear any interest and will be refunded to the unsuccessful tenderers whose tender is not accepted.

The tender paper should be reached by 11.00 A.M on or before dt.26.04.2021. and there after tender will not be accepted. The tender received in due time shall be opened on the same day i.e. 26.04.2021 at 12.00 Noon in the office of the undersigned in the presence of the tenderer or their authorized representatives.

The highest tenderer/bidder , whose tender will be accepted shall deposit 25% of the bid amount in full immediately after the auction is confirmed and shall deposit the balance amount there after adjusting the Earnest Money within 7 (seven) days from the acceptance of the tender.

The successful tenderer shall remove the vehicle from the aforesaid premises along with necessary documents of the vehicle within 7 (seven) days from the date of depositing the full amount of the bid money and beyond that date, the custody on safeguard of the vehicle shall be responsibility of the tenderer and no claim or complain on this account shall be entertained. Is case the successful tenderer fail to make the deposit of the total amount as per the tender within the stipulated time, the deposits i.e. Ernest Money and 25% of total bidding amount shall be forfeited.

On failure to remove the vehicle within the stipulated time, the shed rent @1% (One percent) of the tender amount shall be charged for each day or part thereof till removal of the vehicle. If shed rent charged exceeds the sale price deposited by the tenderer the tenderer shall cease to have any right on the vehicle and the amount deposited by his shall be adjusted towards the shed rent and the vehicle shall become the absolute property of the Government free from encumbrance and deposited of by a fresh tender as the case may be.
