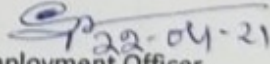
The bidders should fulfill the following terms and conditions:-

1. The vehicle should not be more than 03 (Three) years old.
2. The bidders should give willingness in writing that the agency is ready to send vehicles to interior pockets of the district, whenever required.
3. The driver's salary, repair/ maintenance charges and other operating costs including Road taxes will be borne by the service provider.
4. The fooding of the driver will be borne by the vehicle owner even in the long tour.
5. The Vehicle owner should provide TIN/SRIN number, IT clearance and sales tax clearance certificate of the firm for hiring of the vehicle.
6. The quotation is valid for Eleven months from the date of work order for engagement.
7. Cost towards fuel charge and hiring charge will be provided by the office from time to time when ever funds will be released by the commissioner-cum- Director of Employment and Odisha Skill Development Authority, Bhubaneswar, ( It may take 6 to 12months to be release funds to the firms on receipt of funds from the Govt. DEO is not bound to pay at the every month end)

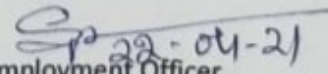
