Office Order

In Pursuance of GO No.21251/H dt.29.07.2021 of Health & FW Dept. Odisha, Bhubaneswar, Nursing Service (Method of Recruitment & Conditions of service) Rule 2019 and amended in 2020 read with Resolution No.1066/GAD dt.16.01.2014 of GA and PG Department, Odisha, the following candidates selected as per OSSSC Notification No.493/OSSSC dt.07.05.2021 have been appointed as Nursing Officer on contractual basis against govt. sanctioned vacant posts of the respective cadre. The appointment is subject to the condition that, if any further shortcoming/discipencies are noticed later on or any adverse report will be received from OSSSC during validation regarding their documents submitted the appointment shall be terminated forthwith.

Other Terms & conditions of service will be as per the service condition as laid down in GA Deptt. Notification No.32010/GAD-SC-Rules-009-2013/Gen dt.18.11.2013. On such induction as contractual Govt. employee, they will be entitled for consolidated monthly remuneration of Rs.10,000/-PM under ORSP Rule-2017.
