
EXPRESSION OF INTEREST (EOI)

Expression of Interest (EOI) is invited by the CDAO- cum- Project Manager NFSM, Jharsuguda from intending Bidders/Agencies from reputed firms for empanelment for the production of Documentaries/Films on different demonstration programme and Preparation of Display Board with Iron framing and Cottons Flags under NFSM Programme 2021-22. The intending Bidders/Agencies will submit the EOI documents with rate (including GST) by the seal cover separately to the Project Manager, NFSM, Jharsuguda by 07.09.2021 up to 12 Noon and it will be open in the same day at 3 PM in presence of the selection Committee constituted by the CDAO – cum Project Manager, NFSM, Jharsuguda. The CDAO – cum Project Manager, NFSM, Jharsuguda will not be liable for any delay or for not offering the EOI in the stipulated date and time mention above. The Bidders /Agencies may also submit their EOI through ^{Read} mail, post or in the Office of the undersigned during the working hours.

List of Documents to be submitted


1. Self certificate stating that the Agencies has not been blacklisted in the past.
2. The agencies must furnish Income Tax returns for the financial year 2019-20, 2020-21 and a copy of their GSTIN registration certificate and clearance up to March 2021.
3. The Agencies must have experience in documentary preparation of videos/CDs/DVDs for at least three years of demonstration programme under Dept. of Agriculture, Odisha (copies of work orders /Agreements to be furnished year wise). The Agencies must have also the experience for last three years in preparation of display board for demonstration conducted under different Agriculture programmes.
4. The authority reserve the right to accept or reject any or all the quotations without assigning reason thereof. Besides, receipt of incomplete form after due date and time will be rejected.
5. Payment to the Agencies will be made after successful completion of the Programme and submission of qualitative and meaningful CDs/DVDs and Spiral binding Album (coffee table Book) with minimum 50 photos with HD quality (3 Copies each)and as per the rate fixed by the P.M NFSM , Jharsuguda.
6. The contract for providing the service will be for one year from the date of selection of bidders. The authorities reserve the right to cancel or terminate the Agency/Agencies owing deficiency in service or breach of Guideline.
7. Display board with iron framing of size 8'x5' at each Block point and size 5'x3' for every 100 ha and 100 numbers of cotton flag for each 100 ha Demonstration to be prepared and raised at the site.
8. The documentation of the demonstration programmes will be made starting from the Land preparation up to harvesting of the crop which include different training programme, field days, control of pest incidents, application of different PP chemicals etc.






