The Tenderer are required to send their tender papers through **Registered Post / Speed Post only** to the Block Development Officer, Kolabira, At/Po- Kolabira, Dist.- Jharsuguda, Pin-768213, so as to reach this office **by Dt.08.09.2021, within 2.00 PM**, after which, no bid will be considered.
