In pursuance of letter No.482(C)/OSSSC dated 28.4.2021 ,No.529(C)/OSSSC dated 19.05.2021 of Odisha Sub-Ordinate Staff Selection Commission and letter No.12466/WCD dated 13.08.2021 of Women & Child Development Department ,Odisha , the following candidates those who have been provisionally selected as Junior Assistant are hereby appointed as Junior Assistant(Statistics) . Women & Child Development Department, temporarily on contractual basis with consolidated monthly remuneration of Rs. 8,880/- (Revised) in the Pre-Revised Scale of Pay PB-I Rs. 5200-20200/- with Grade Pay- 1900/- as per the revised terms and conditions mentioned below.

Terms and Conditions

1. The terms and conditions of Service and the tenure of Contractual Appointment to the post of Junior Assistant ,Women & Child Development Department will be regulated by the Odisha Group – C & Group – D posts (Contractual Appointment) Rules 2013. They will continue on contractual basis for a period of six years. During the period of contractual appointment they will draw consolidated monthly remuneration of Rs. 8,880/- (Revised) in the Pre-Revised Scale of Pay PB-I Rs. 5200-20200/- with Grade Pay- 1900/-.They will not be entitled to DA, HRA, RCM and other allowances during the period of contractual appointment.
2. The appointees will be entitled to leave under the provisions of the Odisha Leave Rules, 1966 and shall abide by the Odisha Civil Services Conduct Rules, 1959 and subject to the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962.
3. The appointees will be enrolled under the new pension scheme contained in the Odisha Civil Services (Pension) Rules, 1992 from the date of Contractual appointment.
4. On the date of satisfactory completion of six years of contractual service they will be deemed to have been regularly appointed and a formal order of regular appointment shall be issued.
5. The appointment is purely for public service and needs good antecedents which would be ascertained after such enquiry as Government may consider necessary.
6. The appointment is purely Contractual, temporary and terminable at any time without assigning any reason thereof.
7. The appointees will produce medical fitness certificate from a Medical Officer not below the rank of a CDMO/ District Medical Officer/ Medical Officer of equivalent rank.
8. The appointees should furnish two character certificates issued by two Gazetted Officers of State/ Central Govt. at the time of joining.

9. The appointees shall affirm an Oath at the time of joining so as to show allegiance to the Constitution of India and remain diligent and duty bound to their assignment.
10. The appointees should submit the "Attestation form" immediately after joining for verification of character and antecedents.
11. The appointees are to join before the respective head of establishments in between **26th August, 2021 to 4th September, 2021** save for valid health reasons failing which steps will be taken for termination of the orders of appointment.
12. The appointees are required to produce all Original Certificates i.e. HSC Mark sheet, HSC Certificate, +2 (or equivalent) Mark sheet, +2 (or equivalent) Certificate, Graduation Mark Sheet and Certificate, Resident Certificate and Caste Certificate etc. at the time of joining for verification and submit attested copies of the Certificates at the time of joining.
