TERMS & CONDITIONS:

1. The intending bidder are advised to submit the sealed tenders in a single cover which should accompany with the amount of Earnest Money Deposit (EMD) of Rs. 1500/- (Rupees One thousand five hundred) only in shape of Bank Drafts payable at SBI, Jharsuguda in favour Superintendent of Excise, Jharsuguda and the cover should be super scribed as "Tender for Vehicle". The EMD amount will be refunded immediately to the unsuccessful tenderers only after finalization of the tender process.

2. Offers received within the dateline shall be opened on 28.09.2021 at 11.00 AM and in presence of tenderers or their authorized agents, the committee members. After that no tenders will be entertained / considered. Further, the tenderes who have not duly filled and not having valid Bank Draft towards EMD amounts shall liable to be rejected.
3. The highest offer at or the above the upset price shall be approved by the competent authority then and there. The highest tenderer shall deposit 25% of the auctioned sale amount immediately and the balance 75% within 7 days of the approval of the offer.
4. If minimum price is not available by sealed tender, the competent authority may dispose the vehicle through negotiation at a price of not less than the highest price offered by the highest tenderer.
5. On failure to make payment as aforesaid deposits (Including EMD) shall be forfeited and the vehicle put to fresh tender as the case may be.
6. The vehicle shall not be delivered to the tenderer until after realization of auctioned or negotiated amount and before completion of requisite formalities. Tools, Instruments and spare parts shall not be delivered with the vehicle.
7. The tenderer shall remove the vehicle from the site within 7 days from the date of depositing the full amount of tender or negotiated amount. The custody or safe guard of the vehicle shall be the responsibility of the tenderer and no claim or complaint on that account shall be admissible.
8. On failure to remove the vehicle within the time as aforesaid, ground rent @ 2% of the auctioned amount shall be charged for each day or part of the day till the removal of the vehicle from the site.
10. If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the vehicle and the amount deposited by the tenderer shall be adjusted towards the ground rent and vehicle shall become absolute property of Government free from all encumbrances and disposed of by fresh sealed tender as the case may be.

N.B: The undersigned will not be responsible for any damage / pilferage cause to the vehicle during the above period. The undersigned reserves the right to reject any or all bid without assigning any reason thereof. The decision of the undersigned is final in case of any dispute.
