

INSTRUCTION TO BIDDERS

A. GENERAL INFORMATION

1. District Rural Development Agency, Jharsuguda requires services of reputed, well established and financially sound Human Resource Service Providers/ Agencies (HRSPA) to provide services of different categories of manpower for DPMU & BPMU under Rural Housing Schemes for carrying out day to day activities under jurisdiction of DRDA, Jharsuguda. The categories are,

For DPMU: One District Project Coordinator (DPC)
 One District Project Executive (DPE)
 One District Call Centre Executive (CCE)

For BPMUs: 5 Block Project Coordinators (BPC)
 5 Block Project Assistants (BPA)

It may be indicated here that the aforesaid categories of manpower who are currently working in DPMU and BPMUs under DRDA, Jharsuguda through UNDP in Rural Housing project will be given preference as per Govt. letter No. 16965 Dt. 01.10.2021.

2. The period of contract for providing the aforesaid manpower is likely to commence from **10.12.2021** and will continue till **31.03.2023**. DRDA, Jharsuguda, however, reserves right to terminate this initial contract at any time after giving **one month's** notice to the selected Service Provider Agency.
3. The agency shall be responsible for payment of fixed remuneration to the Human Resource every month in time as per Government policy and guidelines/ wage policy. The remuneration of different Human Resources are as below:

4. The agency will deposit the EPF and ESI of Human Resource in time and submit proof of the same along with payment of remuneration to HR to DRDA by 10th of each month. In case of any delay, agency will submit reason for it to the satisfaction of DRDA.
5. DRDA will provide the names of candidates, who were working earlier under UNDP to the selected agency. The requisition for human resource will be given to the agency by DRDA, Jharsuguda as per need/ requirement from time to time during the contract period. Whenever any vacancy arises due to resignation /termination/ death of Human Resources, upon receipt of requisition the agency will give a list of manpower at least 3 times of the requirement. The list should be accompanied with detailed information of manpower within stipulated period specified in the requisition. The suitable manpower will be engaged by DRDA, Jharsuguda following due procedure.

6. In case of unsatisfactory performance of any Human Resource, DRDA, Jharsuguda will inform the agency to withdraw the person/ persons and replace him/her with a suitable candidate immediately following due procedure mentioned above.
7. The agency will be responsible to conduct a thorough antecedent verification of the manpower to be deployed and submit an undertaking, in writing, regarding the same. No person with criminal antecedent/ criminal & vigilance cases shall be deployed.
8. The agency shall at all times indemnify and agree and undertake to defend and hold DRDA, Jharsuguda, innocuous against all liabilities, damages, losses, expenses, claims, suits, proceedings, judgements, settlements, actions, costs of any nature whatsoever, whether directly or indirectly arising out of agreement executed between agency and DRDA, Jharsuguda.
9. The interested bidders may visit DRDA, Jharsuguda on any working day between 10.00 AM to 5.30 PM (Office Hours) to have thorough understanding of the work to be performed before preparation and submission of the bid.
10. In case the quotation/ financial bid of two or more bidders become equal, to ascertain the lowest bidder L1, process of draw of lot will be resorted.

The Technical Bid of only those firms which secures more than 60 marks as per the above will qualify for the opening of the financial bid.

11. Statutory Rules, Acts and Regulations:

- I. The HRSPA shall indemnify DRDA, Jharsuguda against all claims which may be made under the Minimum Wages Act, Provident Fund Act, ESI Act, Payment of Bonus Act, Industrial Dispute Act, Payment of Wages Act or any Statutory modifications or, any other Acts, Rules and Policies as applicable.
- II. The HRSPA shall be responsible for any accidents caused to the workers and damage to the equipment during the period of contract. DRDA, Jharsuguda shall no way be responsible for any of the accidents.
- III. For any failure of implementing the statutory rules and regulations by the HRSPA, DRDA, Jharsuguda reserves the right to recover the same from the bills and security deposit of HRSPA.
- IV. Any violation or irregularity of HRSPA in respect of payment Remuneration, EPF/ESI Contributions, Leave salary as per Act and agreement if, brought to the notice of the authority of DRDA, Jharsuguda, it would be referred to Labour Department for taking legal action against the concerned HRSPA and without prejudice to the right of DRDA, Jharsuguda to terminate the contract in such cases.

B. Submission of Bid

The proposal complete in all respect as specified must be accompanied with a Non-refundable Demand Draft/ Banker's Cheque amounting to Rs.5,000/- (Rupees Five Thousand) only towards Bid Process Fee in favour of Project Director, DRDA, Jharsuguda drawn in any nationalised/ Scheduled, commercial bank and payable at Jharsuguda failing which, the bid will be out rightly rejected. The bid should be sent through Speed Post/ Registered Post so as to reach the Authority on or **before 08.12.21 by 5.30 P.M.**

The authority will not be responsible for any postal delay. *Bidders shall also submit a declaration stating that they shall submit to the Authority an EMD amount equivalent to 3% of the estimated amount if the Authority demands.* Bids without bid processing fee and Bid Security Declaration shall be rejected. Bids submitted after due date will be summarily rejected.

The bid has been invited under two bid systems i.e. Technical Bid and Financial Bid. The bidders are advised to submit two separate envelopes super scribing

Selected bidder will have to deposit a Performance Security of 3% of the annual contract value in the form of Bank Draft/TDR from any nationalised/ scheduled, commercial Bank situated within Odisha duly pledged in favour of Project Director, DRDA, Jharsuguda. Failure to comply with the requirements shall constitute sufficient grounds for forfeiture of the Performance Security Deposit. The performance security deposit shall be refunded after successful completion of the tender period upon written request for the same by the bidder.

I. Undertaking regarding non-pending of any judicial proceedings (On bidder's letter head)

Any deviation from the prescribed procedures /required information/ formats/ conditions shall result in out-right rejection of the bid. Any conditional bid shall be out rightly rejected.

All entries along with the pages in the bid document should be legible, filed-in clearly and signed by the authorised representative. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorised signatory should be attached.

The Technical Bid will be opened on **09.12.21 at 12.00 P.M.** in presence of the authorised representatives of the bidder who wish to be present on the spot at that time. The bid shall be valid for a period of **90 days** from the date of opening of the bids and no request for any variation in quoted rates and / withdrawal of bids on any ground by the bidder shall be entertained. Validity of the bids can be extended on mutual consent.

To assist in the analysis, evaluation and computation of bids, the authority may ask the bidders individually for clarification of their bids. The request for clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.

However, the decision of the authority shall be final & binding upon the bidder during the overall selection process.

The quoted rates shall be as per the prescribed remuneration and shall include all statutory obligations.

The service provider shall be liable for all kinds of dues payable in respect of manpower deployed/ provided under the contract and the authority shall not be liable for any dues for availing the services of the personnel.
