So this ward is now reserved for BCC(W) on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994.  Hence, the petition is not sustainable and is rejected.

Ward No. 8 was reserved for ST(W) in 2015 and was reserved as BCC, UR & WOMEN in the year 2000, 2005, 2010 respectively. So this ward is now reserved for BCC on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994. Hence, the petition is not sustainable and is rejected.
10	1	Sri Palasara Bag, Pratap Jaypuria, Mohit Jaypuria & others.	They have requested for change the reservation of seats from ST to SC.	Ward No. 10 was reserved for WOMEN in 2015 and was reserved as SC, BCC & UR in the year 2000, 2005, 2010 respectively. So this ward is now reserved for ST on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994. Hence, the petition is not sustainable and is rejected.

Ward No. 13 was reserved for WOMEN in 2015 and was reserved as UR, BCC(W) & ST in the year 2000, 2005, 2010 respectively. So this ward is now UNRESERVED on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994. Hence, the petition is not sustainable and is rejected.

Ward No. 16 was reserved for ST in 2015 and was reserved as BCC(W), SC & SC(W) in the year 2000, 2005,2010 respectively. So this ward is now BCC(W) on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994. Hence, the petition is not sustainable and is rejected.
