The following objection petitions have been received against delimitation of wards and reservation of seats for ensuing General Election to ULB-2022 of Brajrajnagar Municipality as per Draft Notification No.12252 Date-09.11.2021. The objection petitions have duly been heard and verified thoroughly on its merit and action has been taken under Sec.11 of Odisha Municipal Act, 1950 and Odisha Municipal (Delimitation of Wards, Reservation of Seats & Conduct of Election) Rules, 1994. The details of the objection petitions and action taken are given below:-

They have also stated that the reservation of a Ward shall be changed after two terms of General Elections. 3. They have objected for delimitation of seats.	Ward No.05 was reserved for BCC in 2013 and was reserved as UR, SC & W in the year 1997, 2003 & 2008 respectively. So this ward is now reserved for ST(W) on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994. Hence, the petition is not sustainable and is rejected. The reservation of seats to different Wards by rotation in a Municipal area at every General Elections is done as per the Odisha Municipal Laws Amendment Act, 2021 published vide Law Department Notification No. 1643, dated 08.10.2021. The delimitation has been done as per Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994 and vide Resolution dated 26.10.2021 of the Brajrajnagar Municipal Council.

Ward No. 19 was reserved for BCC(W) in 2013 and was reserved as ST & SC in the year 2003 & 2008 respectively. So this ward is now reserved for Women on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994. Hence, the petition is not sustainable and is rejected.

So this ward is now reserved for ST on rotation basis for the ensuing Election u/s 11 of Municipal Act 1950 & Orissa Municipal (Delimitation of Wards & Reservation of Seats and conduct of elections) Rule 1994. Hence, these petitions are not sustainable and are rejected.
