
NOTIFICATION

Whereas, the provisional notification in Form- XXII of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 showing the division of the **Jharsuguda Municipal Council** into Wards and Reservation of seats as required under sub-section (3) of Section 12 of the Odisha Municipal Act, 1950 was published in the notification bearing No. 566 dated the 13th January, 2022 for the purpose of giving opportunity to the persons to file appeal, if aggrieved against the decision of division of wards and reservation of seats in the said Council;

And, whereas, appeal filed before the Appellate Authority within fifteen days from the date of publication of the said provisional notification has been heard by him and passed orders on the said provisional notification which was communicated by the State Government in their Letter No. 1723/HUD Dated 30.01.2022;

Now, therefore, in exercise of the powers conferred by sub-section (3) of Section 12 of the said Act, the District Magistrate, Jharsuguda do hereby divide the area of the **Jharsuguda Municipal Council** into **24 (Twenty Four) Wards** as specified in Column (2) of the Statement-I below with the description and boundaries of the said Wards against each in Columns (3) and (4), respectively, thereof for the purpose of ensuing election of Councillors to the same and determine the Wards as specified in Column (2) of the Statement-II below in which the seats reserved under section 11 of the said Act shall be set assigned against each in Column (3) thereof.



ORDER

Date:- 25.01.2022

The appeal petition filed u/s 12(3) of the O.M. Act, 1950 against the decision of the District Magistrate, Jharsuguda on reservation of seats of Jharsuguda Municipality is taken up for hearing today by virtual mode.

The Executive Officer, Jharsuguda Municipality is present with records.

The appellant Sri Harish Ganatra is present during hearing.

Heard the appellant.

The appellant Sri Harish Ganatra in his appeal petition and during hearing submitted that, the District Magistrate, Jharsuguda without giving the person concerned opportunity of being heard has issued provisional Notification on 13.01.2022. Further he alleged that reservation of seats has been assigned in favour of different categories without following the reservation criteria leaving the eligible wards where the populations are higher as per descending order. Especially reservation of ward No. 18 for Women in complete violation of all provisions and guideline.

Examined the appeal along with the contention raised by the appellant with reference to Notification No. 566, dated 13.01.2022 issued by the District Magistrate, Jharsuguda and observed that, the reservation assigned in the aforesaid notification in favour of SC, ST & Woman category, some modification is required as per provisions of section 11 of the O.M. Act, 1950 read with rule 3 of the O.M.(D.W.R.S. & C.E.) Rules, 1994.

Accordingly, the reservation status of different wards of Jharsuguda Municipality will be as mentioned in the table below.
