

Sealed quotations/tenders are invited from interested reputed Travel agencies/Tour Operators or private individuals for providing One petrol driven vehicle **Ertiga**, which shall confirm to the Terms and conditions (Anexure-I) for official use by the Chair Person , Brajrajnagar Municipality on monthly rent basis:

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate , valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle .
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of account payee Bank Draft drawn in favour of the **Executive Officer, Brajrajnagar Municipality** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rent of hire charge be quoted separately in the general bid information(excluding fuel and lubricants). The maximum hire charges per month is Rs 31,000/- (Rupees Thirty one Thousand)only as per Govt. norm.
6. The vehicle must achieve a fuel efficiency of 10(Ten) Kms per Litre.
7. The details of the make and year of manufacture of the vehicle, registration no., mileage(Kms covered per Litre and name and address of the driver with

Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender (Annexure- III).

8. The Quotation completed in all respect should reach the undersigned on or before **06.4.2022 by 4.00 p.m** by p.m by Regd. Post and shall be opened on the same day at **5.00 p.m** in presence of the bidders or their authorized representatives.
9. The application form of quotation/tender containing general Bid information (Annexure-II) & terms and conditions for hiring of vehicles etc. (Annexure-I) will be available within this office of Brajrajnagar Municipality from on or before **04.04.2022 by 4.30p.m** only working day. .
