Quotation Call Notice

1) In continuous to this Office Quotation Call Notice No.283 dated 28.03.2022, sealed quotations in plain paper are invited again from intending Register Firms/ Agencies for **Webcasting of the critical and Vulnerable Polling Stations** in connection with Bye Election to 06-Brajrajnagar Assembly Constituency of Jharsuguda District.

The quotationers are informed to quote their **rate per day** on the above item of work. They are also required to mention availability of number of CCTV at their firm separately.


The Quotation should reach in the District Election Office, Jharsuguda on or before **1.00 PM on date 21.04.2022** and it will be opened on the next day i.e. date 22.04.2022 at **10.00 AM** in the presence of the committee duly approved by District Election Officer, Jharsuguda. The quotationers or his authorized agent should be present at the time of opening of the quotation on the date and time fixed. Negotiation may be made for finalization of rate with the quotation.

The quotationers should have valid GST No. (Self-attested copy of the GST Registration Certificate is to be submitted), must submit copy showing up to date deposit of GST and valid PAN (copy to be submitted).

Each quotationer shall have to deposit non-interest EMD of **Rs.10,000/-** (Rupees Ten thousand) only in shape of account payee/ Bank Draft payable to the District Election Officer, Jharsuguda which will be refunded to the unsuccessful quotationers or whose quotation are not accepted. The EMD of the successful quotationer will be refunded after completion of the validity period. The total offer price per unit shall be inclusive of GST, transportation and installation charges. EMD money is not required for the quotationers who have submitted EMD as per the Quotation Call Notice No.283 dated 28.03.2022.

The successful firm/ bidder must sign an agreement for a period of six months from the date of signing of agreement / finalization of tender and will complete the delivery of items within 3 days unflinching after issue of work order, failing which the order will stand automatically cancelled. The rate of unit-wise item should be quoted distinctively. Failure to supply the order in full within the stipulated period may lead to forfeiture of EMD and action as deemed proper shall be initiated against the quotationer.


