Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in all the offices of Project Director, DRDA, Jharsuguda/ Collector, Jharsuguda / Executive Officer of Jharsuguda/Brajarajnagar/Belpahar Municipality/Executive Engineer, RW Division,Jharsuguda/ Executive Engineer, R&B Division,Jharsuguda/Executive Engineer,MI Division,Jharsuguda/Executive Engineer,PH Division,Jharsuguda/All Block Development Officers, Jharsuguda during office hours every day except on Sundays and Public Holidays till last date of sale and receipt of tender papers.
2. **Cost of Tender Paper:** - Bids must be accompanied by the paper cost of the amount specified for the work in the above table (Column No.7) in shape of Demand Draft (non-refundable) drawn in anyScheduled/Nationalized Bank in favour of **Block Development Officer, Jharsuguda.**
3. **Earnest Money Deposit:** - The bid must be accompanied by Earnest Money Deposit(EMD) of the amount @ 1% of the bid value as mentioned in the Column No.6 of the above table in shape of fixed receipt of Schedule Bank/Post office Saving Bank Account/National Saving certificate/Post office time Deposit Account duly pledged in favour of Block Development Officer,Jharsuguda.
4. **Sale and Receipt of Tender Paper:** -The sale of the Bid documents shall also start from **27.05.2022 at 08.00 A.M. to dt.04.6.2022 up to 1.00 P.M.** on all working days in the office of the **Block Development Officer, Jharsuguda** and the last date for receipt of Bid documents is **13.06.2022 up to 1.00 P.M.** The bid documents will also be available in the district website [www.jharsuguda.nic.in](http://www.jharsuguda.nic.in) from **27.5.2022 at 8.00 AM to 13.6.22 up to 1.00 PM.** Interested bidders may also obtain further information at the same address.  
Bid documents in a sealed envelope should be received in the office of Block Development Officer, Jharsuguda through **Registered Post / Speed Post only**(No tender paper will be received by hand or courier service) and should be super scribed by the **NAME OF WORK** "(written in Capital Letter) on the Body of the cover. Bidding documents will be Dispatched by registered/speed post only. The authority will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
5. **Date of Opening of the tender Paper-**The bids will be opened on dt- **16.06.2022 at 03.00 A.M.** in the Block Conference Hall , Jharsuguda in the presence of the bidders who wish to attend. If the office happens to be closed (holiday) on the date of receipt/opening of the bids as specified, the bids will be received/opened on the next working day at the same time and venue without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing in the notice board of **Panchayat Samiti, Jharsuguda.**
6. **Additional Performance Security Deposit-** Additional Performance Security shall be obtained from the bidders, when the bid amount is less than the estimated cost put to tender. In such an event, *only successful* bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the Additional Performance Security as per the following rate as per O.M No-4559 dated 05.4.2021 of works Department, Govt. of Odisha and O.M No-8475/F,dt-5.4.2022 of Government of Odisha Finance Department.

Estimated cost minus the quoted amount as Additional Performance Security Deposit in shape of Fixed Deposit receipt of Scheduled Bank / Post Office Savings Bank Account / National Savings Certificate / Post Office Time Deposit Account duly pledged in favour of Block Development Officer, Jharsuguda within seven days of issue of Letter of Acceptance (LoA), otherwise the bid shall be cancelled and security deposit shall be forfeited and further proceeding for black listing shall be initiated against the successful bidder. (as per Govt of Odisha works department office memorandum no. 14299, dtd.03.10.2017 and amendment of para no 3.5.5 (V) of OPWD code volume 1).

7. Bid documents can be purchased from the office of the Block Development Officer, Jharsuguda for the work on payment of tender cost of Rs.6000/- (Rupees Six thousand only) in shape of Demand Draft of any Scheduled/Nationalised Bank in favour of Block Development Officer, Jharsuguda (Non-refundable) in a separate envelope marked as "COST OF TENDER DOCUMENT FOR THE WORK \_\_\_\_\_" (As mentioned in the DTCN Column-2 of the above Table for each project)
8. The following Documents should be furnished with the tender paper for each construction work, failing which the tender is liable for Rejection.
  - A) Self attested copy of valid Contractor Registration Certificate.
  - B). EMD pledged in favour of Block Development Officer, Jharsuguda
  - C) SC/ST Contractors should submit original Affidavit in support of caste certificate and self-attested copy of Caste Certificate.
  - D) Original money receipt/Bank Draft towards the cost of Tender paper.
  - E) Original Affidavit in support of the authenticity of Documents including EMD etc.
  - F) No Relation Certificate with the signature of Tenderer.
  - G) Self-attested copy of Valid Labour license.
  - H) Self attested copy of valid PAN Card & GST Certificate
9. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit regarding list of works awarded without submission of EMD/ISD during the current financial year. He should also produce original contract license at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participation in tender during a financial year, otherwise their tender will be liable for rejection.
10. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and self-attested copy of caste certificate, otherwise their tender will be liable for rejection.
11. Tender paper is liable for rejection in absence of any required documents.
