In pursuance of Memo No.WCD-ICDS-G-VEH-0002-2022-7894/WCD dt.09.05.2022 of W&CD Department,Odisha and District Office, Jharsuguda Letter No.1068/SW dt.16.06.2022, Sealed quotations/Tenders are invited from interested Travel Agencies/Tour Operators or Private Individual for providing **01(One)** no. of Non-AC Diesel driven Vehicle(**Bolero/TUV300/Sumo Gold/Ertiga**) having sitting capacity not more than 10(Ten) including Driver,which shall conform to the term & conditions as prescribed in **(Annexure-II)** for official use in the **Office of the CDPO,ICDS Project, Lakhanpur** on monthly rent basis for current financial year-2022-23. The undersigned reserves right to accept or reject any Quotation/Tender or all the quotations/ Tender without assigning any reason thereof.

1. The Vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial Registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate,Valid Contract Carriage permit, Proof of upto date tax payment etc. which are mandatory for playing of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behave, gentle and obedient in nature. The salary of the Driver shall be borne by the Owner.
4. The hire charges will be paid to the vehicle owner on monthly basis after submission of up to date log Book. No advance payment will be made.
5. A sum of **Rs.5,000/- (Rupees Five thousand)** only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **Child Development Project Officer,Lakhanpur** payable at **SBI,Lakhanpur** and submitted along with the tenders as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
6. The monthly rate of hire charge be quoted separately in the general bid information (Excluding fuel and lubricants).
7. The vehicle must achieve a fuel efficiency of **10(Ten) KMs per liter**.
8. The details of the make and year of manufacture of the vehicle, Registration No.,Mileage(Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/Tender at**(Annexure-III)**.
9. The quotation completed in all respect should reach to the undersigned on or before **dt.16.08.2022 till 5.00 PM** during office working hours and shall be opened on **dt.19.07.2022 at 11.00 A.M.** in the office chamber of Child Development Project Officer,Lakhanpur in presence of the bidders/quotationers or their authorised representatives. The sealed envelope must be superscribed with **"Quotation/Tender for Hiring of Vehicles"** addressed to the Child Development Project Officer, ICDS Project,Lakhanpur,Dist-Jharsuguda,Odisha,PIN-768219.

The application form of quotation/tender containing General Bid information & Term and Conditions for hiring of vehicle etc. will be available with the Office of the CDPO, ICDS Project, Lakhanpur on payment of **Rs.100/- (Rupees One Hundred) only (NON REFUNDABLE) from 02.08.2022 to 16.08.2022** during office working hours except holiday towards cost of the application.
11. The eligible bidders shall commence the service from the date of place of the order and shall continue to provide the services.
12. The successful tenderer/quotationer will have to execute and sign the agreement with the undersigned as per Terms & Condition.
