

Terms and conditions :-

1. The cost of bid documents (non-refundable) mentioned in column No. 5 should be deposited in shape of cash/demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Brajrajnagar Municipality payable at Brajrajnagar.
2. The cost of EMD mentioned in column No. 3 should be deposited in shape of demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Brajrajnagar Municipality payable at Brajrajnagar.
3. Quoted rates should be quoted clearly in both figures & words with corrections duly attested by the quotationers.
4. Intending quotationers should possess prior experience in execution of identical nature of Business within Brajrajnagar Municipality Area.
5. The firm/ institution should have Voter Id Card, Aadhar Card, GST Registration Certificate, PAN Card. No undertaking would be allowed against non-submission of any required document.
6. No Non-Veg shop will be allowed in the Shopping Complex.
7. The minimum Security Deposit will be Rs.1,00,000/-(Rupees One Lakh) only.
8. The bidder quoting maximum price will become the successful bidder.
9. An advance of Rs.50,000/-(Rupees Fifty Thousand)only has to be deposited by the bidder which will be adjusted from their Rent 50/50 basis. The rent of the shop will Rs 1500(Rupees One Thousand Five Hundred)only and the successful bidder has to pay Rs.750.00(Rupees Seven Hundred Fifty) only towards the monthly rent till the amount will be adjusted.
10. Internal Electrification will be done by Brajrajnagar Municipality and the power connection has to be taken by the party in the name of the Executive Officer, Brajrajnagar Municipality.
11. In case the shop keeper desires to vacate the shop room, he/she can vacate the same within 02(Two) months prior notice so that his Security Deposit will be returned back.
12. The numbering of the shop rooms will start from the Gate Side of Kalinagar Stadium as No.1, 2,3 and end in No.11 towards Mandalia Side.
13. The highest bidder will be eligible for Shop No. 1 and 2nd highest bidder will be eligible for Shop No.02 and so on .
14. The bidder has to specify the nature of business he/she intend to do.
15. No bidder is allowed to participate in more than one shop room.
16. No bidder is allowed to participate from single household family.
17. No successful bidder will be allowed to Sub-let the shop to any body.
18. The EMD of unsuccessful bidder will be returned after 10 days of opening of bid. If any successful bidder fails to deposit the quoted and Advance Money within 10 days to next highest bidder will be treated as successful bidder and the former ones claim will be cancelled.
19. The rent will increase 10% in every 03(Three) years.
