No

tender will be considered valid without payment of the earnest money Bank draft will be returned to the unsuccessful tenders only after finalization of the tenders.

Tender with highest offer of sale price shall be accepted and such tenderer shall have to deposit 25% of the offered amount of the vehicle on the day of acceptance and balance 75% within three days of issue of the intimation letter. On failure to make payment as aforesaid deposit (including earnest money) shall be forfeited.

The tenderer whose offer will be accepted by the authority shall have to deposit 25% of the offered amount of the vehicle on the day of acceptance and balance 75% with three days of issue of the intimation letter failing which the offer will be treated as cancelled and the deposits including the earnest money will be forfeited. The vehicle should be removed from the site with seven days from the date of full payment of the bid amount.

The vehicle should be removed from the site within seven days from the date of depositing the full amount of tendered/negotiated money. Tools, instruments and spare parts shall not be delivered with the vehicle. In case the vehicles is/are not revolved, the custody and safety of the vehicles shall be the responsibility of the tenderer and no claim or complain on that account shall be entertained and ground rent at the rate of 1% of tendered/negotiated money will be charged for each day or part of the day till the removal of vehicle from the site.
