In pursuance of Advertisement No. IIE -121/2021/ 999(C)/ OSSSC dt.30.09.2021 and letter No. IIE - 63/2022/1998/OSSSC dt. 07.12.2022 of Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar, the following selected candidates for the post of Assistant Revenue Inspector under CRE-2021for District & Sub-ordinate Offices of Jharsuguda district are hereby appointed as Assistant Revenue Inspector temporarily on regular basis in the Level-04, Cell-01 under ORSP Rules, 2017 (Scale of Pay PB-I Rs. 5200 -20200/- with Grade Pay- 1900/-) with usual D.A. & other allowances allowed from time to time as per the revised terms and conditions of the Odisha Group "B", "C" and Group "D" posts (Repeal and Special Provisions) Rules, 2022 issued vide Notification No. 29076/Gen. Dt. 16.10.2022 of Govt. in General Administration & Public Grievance Department, Odisha as mentioned below.

Terms and Conditions

1. The appointment is purely for public service and needs good antecedents which would be ascertained after such enquiry as Government may consider necessary.
2. The appointment is purely temporary and terminable at any time without assigning any reason thereof.
3. The appointee will be entitled to leave under the provisions of the Odisha Leave Rules, 1966 and shall abide by the Odisha Civil Services Conduct Rules, 1959 and subject to the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962.
4. The appointee will be enrolled under the new pension scheme contained in the Odisha Civil Services (Pension) Rules, 1992 from the date of his/her appointment.
5. The appointee will produce medical fitness certificate from a Medical Officer not below the rank of a CDMO/ District Medical Officer/ Medical Officer of equivalent rank.
6. The appointee should furnish two character certificates issued by two Gazetted Officers of State/ Central Govt. at the time of joining.
7. The appointee should furnish a declaration to the effect that he has got only one spouse living, if married. In case the declaration is found false at any time, he/she will be liable for termination from Government service.
8. The appointee shall affirm an Oath at the time of joining so as to show allegiance to the Constitution of India and would be diligent and duty bound to his/her assignment.

9. The appointee should submit the "Attestation form" immediately after joining for verification of character and antecedents.
10. The appointment in the post of Assistant Revenue Inspector shall be cancelled automatically if the appointee fails to join in duty on or before **31.12.2022**.
11. The appointee is required to produce all Original Certificates i.e. HSC Marksheet, HSC Certificate, +2 (or equivalent) Marksheet, +2 (or equivalent) Certificate, Resident Certificate and Caste Certificate etc. at the time of joining for verification and submit attested copies of the Certificates at the time of joining.
12. All the appointees will be in probation for a period of 02 (two) years with the effect from the date of joining.

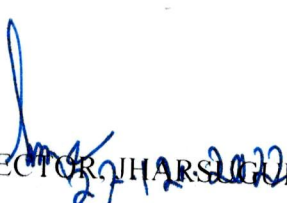

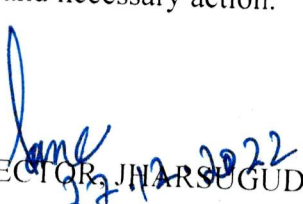
