INVITATION TENDER CALL NOTICE

The Block Development Officer, Kolabira, Jharsuguda on behalf of Governor of Odisha invites **Percentage Rate bids** in sealed cover for the following work from the class of eligible contractors as mentioned in Column-7 (seven) registered with the State Governments having validity of Civil License and contractors of equivalent Grades/Class Registered with Central Government/MES/Railways and other state government having validity of Civil License for execution of **Building work** (excluding EI & PH). The proof of registration from the appropriate authority shall be enclosed along with the Bid. The eligible contractors of the state P.W.D.(R&B)/Water Resources/Rural Works/M.I./C.P.W.D. for the following works eventually to be drawn up in the **P.W.D. P1 forms** in conformity with the Detailed Tender Call Notice. The bidders may submit bids for the following work.

The Tender paper shall be submitted in sealed cover super scribing the Name of the work for tender in capital letter on the top of the envelope & shall contain signed DTCN, attested copy of Contractor Registration Certificate, PAN Card, valid GST Registration/Clearance Certificate, no Relation Certificate & original affidavit regarding authentication of documents of the Tender Notice, other documents required as per the relevant clauses of the DTCN, Tender Paper Cost(Non-refundable) in shape of Bank Draft or Demand Draft drawn in favour of Block Development Officer, Kolabira, Jharsuguda .**

The Tenderer are required to send their tender papers through **Registered Post / Speed Post only** to the Block Development Officer, Kolabira, At/Po- Kolabira, Dist.-Jharsuguda, Pin-768213, so as to reach this office **by Dt.05.04.2023, within 4.00 PM**, after which, no bid will be considered. The Bids received late will not be opened. The authority will not be held responsible for the Postal delay if any or non-receipt of the tender documents in time.

02. The bids received will be opened by Block Development officer, Kolabira/his authorized Officer in presence of the bidders or their authorized representatives wish to attend. If the office happens to be closed on the date of receipt /opening of the bids as specified, the bids will be received /opened on the next working day at the same time & venue.

A. Date and Time of Sale of Tender paper: Dt.24.03.2023 from 10.00AM

B. Last Date of receipt of Tender paper: Dt05.04.2023 till 4.00PM in working days.

C. Date and Time of opening of Tender paper: Dt 06.04.2023 at 11.00 AM.

03. **Earnest Money Deposit (EMD) - 1%** of the tender amount as specified in Col.05. Transfer or adjustment of EMD/Differential amount/Initial Security Deposits (ISD) will not be entertained. The EMD amount will be forfeited if the tenderer backs out from the offer of acceptance of tender by the competent authority

04. **Work Experience-** The Contractor must have executed similar nature of works having Tender Amount more than 50.00lakh(Fifty Lakh) for a single project in last 3 (Three) year.

If the rate quoted by the bidder is less than 15% of the amount put to tender, then such a bid shall be rejected and the tender shall be finalized basing on merits of the rest bids as provision laid down in clause No.36 of Memorandum No. 12366/W, dated 08.11.2013 of Works Department. Govt. of Odisha. But, if more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes) either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidder/their authorized representatives, the concerned SE/Executive Engineer of concerned Division/BDO and DAO will remain present. **Additional Performance Security Deposit:** - Additional Performance Security shall be deposited by the bidder, when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Term Deposit Receipt pledged in favour of Divisional Officer / Bank Guarantee in favour of the Divisional Officer from any Nationalized /Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit / Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder as per Works Department Office Memorandum No.14459 dtd.20.09.2018.

05. **Additional Performance Security-** Letter No-4559/W, Bhubaneswar dt-05.04.2021 Works Dept. Govt. of Odisha. in view of the above the State Govt. is pleased to fixed the following rate of Additional Performance Security.
