Quotation Call Notice for selection of Public Sector Bank for operating accounts of District Mineral Foundation, Jharsuguda

District Mineral Foundation Jharsuguda is inviting sealed quotations in the Letter head from all the scheduled Nationalized Bank of Jharsuguda district empaneled by the Finance department, Govt of Odisha for operation and maintenance of fund of District Mineral Foundation Jharsuguda on the following terms and condition.

General Instruction

1. The filled in sealed quotations indicating the rate of interest on Saving bank deposit and flexi deposit should be submitted before 30 minutes to the selection committee directly on or before 20.04.2023 by 10.00 AM in the Conference Hall of Collector, Jharsuguda
2. Any quotation received beyond the due date and time will summarily be rejected.
3. Public Sector Banks empaneled by Govt of Odisha, Finance Department vide Letter No 26061/F Dt.19.10.2022 (Selection of Banks for handling business and deposits of State Public Sector Undertaking (SPSUs) and State Autonomous Societies for the year 2022-23) will be eligible to participate in the Invitation of Quotation Call Notice.
4. The bank quoting maximum rate of interest shall be approved by the Selection Committee of the District Mineral Foundation for operation and maintenance of the funds account of DMF, Jharsuguda.
5. The rate of interest quoted should remain valid for a period of 30 days and the nominated bank shall not be allowed to withdraw their offer subsequently. In case of

- parking of any deposit pertaining to the said account
6. The bank offering highest rate of interest and better terms and condition shall be selected by the selection committee for such deposit.
 - 7 Selection committee has right to accept or reject any banks offer without mentioning any reason thereof.
 8. Decision of the Selection Committee of the District Mineral Foundation is final and binding.
 - 9.TDS shall be applicable as per the Income Tax Act and other Govt Tax. No other deduction is allowed for any other services.


