**COVID-19 URGENT**

**OFFICE ORDER**

Whereas the District Magistrate & Collector, Jharsuguda is empowered U/s-8 of Covid-19 Regulations-2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared a pandemic.

Whereas the District Disaster Management Authority has the power to take necessary measures U/s 30 & 34 of Disaster Management Act to prevent the spread of this disaster.

Whereas the objective of the administration is to go for immediate geographic quarantine, social distancing, enhanced active surveillance, ensure testing of all suspected cases and compulsory home quarantining of contact cases and their isolation as per need.

Whereas as a case of Covid-19 has been tested positive in Talpatia of Jharsuguda Block and it is necessary to have time and effort for contact tracing up to the last mile and point, so that the scope of transmission is eliminated and the fledging chain is broken.

Now having the perspective of public interest in the background and for the sake of speedy completion of active surveillance in the area of immediate contact and neighborhood, the following area is declared as zone of "containment".

The house of the positive cases having been considered the focal point, a circumference around that as per the following description is hereby declared as zone of containment.

**Boundary point of zone of containment (Map attached)**

The containment-zone shall comprise of the boundary as delineated below.

C1 Shiv Temple → C2 Medicine Store Front → C3 Village N End → C4 Hospital Backside.

The vehicular movement in totality both in public and private is stopped in the containment zone excluding the vehicles permitted for supply of essential items, medicines, health surveillance, sanitization and other necessary activity to be undertaken by District Administration and to be used by the police for enforcement of Law and Order and conformity to stipulations.

All the inhabitants of the Containment-zone will stay in-door and this is to be followed without deviation. Violation will invite strict penal action. The institutions and establishments in the Containment-zone enjoying exemption of lockdown in the Containment area will remain closed. All Govt. and Private Institutions in Containment is closed. The closure and seizure of operation as enunciated in Govt. order No. 1663/R&DM(DM) dt. 31.03.2021 will be adhered to and the

exemption allowed therein will seize to operate in Containment zone. The following officers will act as Nodal Officers to ensure smooth supply of essentials and sanitization of the Containment-zone.

1. Sri Nihar Ranjan Mohapatra MI, Jharsuguda Block- Supply of Essential Commodities.
2. Sri Prasanna Ku. Pandey, BDO, Jharsuguda - Maintenance of sanitation and sanitization of the areas.
3. Sri Dilip Kumar Pradhan, Tahasildar, Jharsuguda - Maintenance of Law and Order.
4. Dr. Dabendra Naik, MO, CHC, Brajarajnagar, Jharsuguda - Health requirement.
5. Overall supervision will be done by Sub-Collector, Jharsuguda
6. Superintendent of Police, Jharsuguda will make necessary arrangement for immediate deployment of adequate police at the points of requirement to be supervised either by Addl. Superintendent of Police or SDPO, Jharsuguda.

#### Contact Tracing

Contacts of the confirmed and suspected cases will be line listed, tracked and kept under surveillance in the period of restriction.

#### Surveillance

The area of Containment will be under active surveillance. CDM&PHO, Jharsuguda will mobilize required work force immediately to conduct the exercise in respect of all the houses in Containment-zone. Supervisory officers will be also named by the CDM&PHO, Jharsuguda at a ratio of 1:4. The active surveillance will start from 27.04.2021 at 8.00 AM in the morning. Since all the families in the area have been provided with mask by the Dist. Administration they may not have any such need. However the visiting teams will be carrying masks with them for delivery at household not having the same. All ILI and SARI case either reported in the last 14 days by the IDSP or ascertained in course of our across-the district exercise will be tracked and reviewed thoroughly in the Containment zone. Swab will be collected from all cases of confirmed contact at the earliest for testing at the designated Labs.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
