No. 5560/Emg. Dated : 12.05.2021

Where as the undersigned deriving power U/s 8 of COVID Regulations, 2020 framed by Govt. of Odisha and Sec. 30 & 34 of Odisha Disaster Management Act, 2005 some locations were declared as containment zones in Jharsuguda.

Now for the sake of restoration of normal life in the areas, it is ordered annulment of the impugned orders as mentioned below which gave effect to restriction and regulation with regard to Containment and the activities in Buffer Zone. **This order of rescission will take immediate effect. All the arrangements made by the administration with regard to supply of essential commodities stand withdrawn. However the measures of prohibition and restriction as enunciated in Govt. order No. 2328/R&DM(DM) dt. 01.05.2021 will continue to be in force.**
