
Notice

3. Certificate of registration under Society Registration Act-1860.
4. Certificate of registration under Section 139 (A) & 12 (AA) of Income Tax Act-1961
5. Proof of documents working in the District of Jharsuguda for the welfare and rehabilitation of PwDs.
6. Proof of documents (Certificates/citations) if any in support of good track of record regarding the functioning/ activities of the organization.






