OFFICE ORDER

Dated: 05.07.2020

Whereas the District Disaster Management Authority has the power to take necessary measures U/s 30 & 34 of Disaster Management Act to prevent the spread of this disaster.

Whereas the signatory of this order has been empowered U/s-8 of Covid-19 Regulations-2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared a pandemic.

Whereas in the Order No. 3856/R&DM(DM) dated. 30.06.2020 of Office of the Special Relief Commissioner, Government of Odisha, the District Collectors/Municipal Commissioners have been authorized to impose area specific additional restrictions on activities outside the Containment zones, or impose such restrictions as deemed necessary for containing the spread of COVID-19.

Whereas the objective of the district administration is to go for contingent measures to contain the spread of COVID-19 in Jharsuguda District.

Whereas in Jharsuguda district after the relaxation in lock down conditions and opening up of economic activities, people have started coming from other districts of the State and it is observed that incomers/returnees from hotspot areas of the State have been found positive for COVID-19 and being asymptomatic, they may infect the neighbourhood unnoticed.

Whereas it is further observed that foot fall from some hot spot areas of the State in Jharsuguda has increased in last few days, i.e. mostly by unguided travel.

Now having the perspective of public interest in the background and for the containment of COVID-19 in the District of Jharsuguda, I Saroj Kumar Samal, OAS, Collector & DM, Jharsuguda order implementation of the following direction.

1) That the incomers/returnees from following areas of the State save the provision of exception will be kept in institutional quarantine for a period of 14 days. However incomers/returnees interested for paid quarantine will be allowed the facility at the hotels/lodgings permitted vide this Order No. 6402/Emg., dated. 25.05.2020 and Order No.9250/Emg., dated. 27.06.2020. The people going back in 72 hours will be exempted from quarantine. But the residents of this district going on work to these areas on return will be quarantined irrespective of the period of travel and stay. This restriction will not apply to travel on Govt. and Court assignments.

1. Ganjam (entire district)
  2. Cuttack (entire district)
  3. Panposh Sub-Division of the district of Sundargarh
- 2) That responsibility is thrust upon the employers of all Commercial establishments/ Industries, Heads of such units, Managers, Contractors, Labour Contractors and Service Providers to ensure that professionals, employees, work men and labourers across the categories i.e. permanent, temporary, contractual and of daily wage brought in by contact and landing on own at work sites of their management from these named areas shall be quarantined at the cost of the former for 14 days before the latter start working at respective sites. This regulation will also apply to construction contractors of the projects both of public and private domain and private house owners bringing labourers/skilled workers from these identified areas of the State.

Further it is incumbent upon all of them to keep the following officers informed about such arrival/expected arrival, preferably before actual foot fall in the district or maximum within 06 hours from the time of their arrival.

Deviation will make such Employers, Contractors and other functionaries as named above liable under Sec-58 of Disaster Management Act-2005 and relevant provisions of COVID regulation, 2009. The contractors may further be recommended for black listing besides being criminally liable. Further any person violating the measures of regulation shall be deemed to have committed an offence punishable under section 188 of Indian Penal Code (45 of 1860).

The concerned incident Commander through the Ward Level Committees / Slum Committees/ Surveillance Teams shall keep close watch over the matter and ensure strict compliance of the order.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
