Revised Boundary point of Buffer of containment (Map attached)

The Buffer-zone shall comprise of the boundary as delineated below.

Majhapatra Road → Open Field → Welding Plant E End → Welding plant W End.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.


