Where as the undersigned deriving power U/s 8 of COVID Regulations, 2020 framed by Govt. of Odisha and Sec. 30 & 34 of Odisha Disaster Management Act, 2005 vide this office order No.13036/Emg. Dt.25.08.2020 had declared area in a particular circumference around the household of the case detected positive in Loisingh, GP-Loisingh, Jharsuguda of Jharsuguda Block with the following boundary descriptions at "A" as a segment of containment and the area between the boundary of Containment and an outer line delineated at "B" as Buffer Zone.

Now for the sake of restoration of normal life in both the areas, I Sri Saroj Kumar Samal, O.A.S., District Magistrate & Collector, Jharsuguda order annulment of the impugned order which gave effect to restriction and regulation with regard to Containment and the activities in Buffer Zone. **This order of rescission will take immediate effect. All the arrangements made by the administration with regard to supply of essential commodities stand withdrawn. However the measures of prohibition and restriction as enunciated in Govt. order No. 5039/R&DM(DM) dt. 31.08.2020 will continue to be in force.**

Boundary point of Zone of containment ("A")


The containment-zone shall comprise of the boundary as delineated below.

Boundary point of Buffer of containment ("B")


The Buffer-zone shall comprise of the boundary as sketched below.







1. 14 Nos of contact tracing of COVID-19 no positive case found.
2. Declaration of Containment Zone dt.25.08.2020.
3. Planning and training of Medical Team, Survey Team and Dedicated medical supervision team done on dt.25.08.2020. A total 01no of Medical Team consist of M.O., Staff Nurse and a total 01no. Of survey teams consist of AWW and ASHA.
4. The survey team did not get any SARI and ILI Cases.
5. 14 no's of swab collection of High Risk cases in the containment zone found 14 negative.
6. No SARI and ILI cases found till date. Surveillance activity in this area is saturated.
