
Where as the undersigned deriving power U/s 8 of COVID Regulations, 2020 framed by Govt. of Odisha and Sec. 30 & 34 of Odisha Disaster Management Act, 2005 vide this office order No.12776/Emg. Dt.21.08.2020 had declared area in a particular circumference around the household of the case detected positive near Hatlipada, Jharsuguda of Jharsuguda Municipality as a segment of containment and the area between the following boundary of Containment and an outer line delineated at "B" as Buffer Zone.

Now for the sake of restoration of normal life in both the areas, I Sri Saroj Kumar Samal, O.A.S., District Magistrate & Collector, Jharsuguda order annulment of the impugned order which gave effect to restriction and regulation with regard to Containment and the activities in Buffer Zone. **This order of rescission will take immediate effect. All the arrangements made by the administration with regard to supply of essential commodities stand withdrawn. However the measures of prohibition and restriction as enunciated in Govt. order No. 5039/R&DM(DM) dt. 31.08.2020 will continue to be in force.**

**Boundary point of Zone of containment ("B")**


The Buffer-zone shall comprise of the boundary as sketched below.







**About Containment Zone, Hatlipada, Jharsuguda.**


Sir,

With reference to the subject cited above, I am to inform that the following things has been done in the Containment Zone Hatlipada, Jharsuguda.

1. 17 Nos. of Contact Tracing of COVID-19 Positive Case was done.
2. Declaration of Containment Zone-Dt.21.08.2020.
3. Planning and Training of Medical Team, Survey Team and dedicated medical supervision team done on Dt.21.08.2020. A total of 1 No. of Medical Teams consisting of AYUSH Doctor, One HW (F) and one Staff Nurse and a total of 1 No. of survey teams consisting of AWW, ASHA respectively.
4. The survey team did not get any SARI & ILI Cases.
5. 19 Nos. of Swab collected in the containment zone and all are found negative.
6. No SARI & ILI Cases found till date. Surveillance Activity in this area is saturated.
