In partial modification of this Office Order No.15769/Emg dt. 27.09.2020 pertaining to declaration of Containment zone in Kabrastanpada area of Jharsugujda Municipality, the following revised description in respect of the Zone Containment and Buffer is made.

**Revised Boundary point of zone of containment (Map attached)**

The containment-zone shall comprise of the boundary as delineated below.

C1 Itabhata Chowk → C2 Amaron End → C3 Bajaj showroom Back End → C4 Utkal Jyoti Gate → C5 Railway Colony End → C6 Telibhata Masjid Fron → C7 Dharsadhipa Road.

**Revised Boundary point of Buffer of containment (Map attached)**

The Buffer-zone shall comprise of the boundary as sketched below.

B1- HDFC Bank → B2-Kisan Chowk → B3-Beheramal ROB → B4 Chowikipada Chowk → B5 Masjid Back End.

The remaining part of the Order No. 15769/Emg dt. 27.09.2020 will remain intact.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
